# At 9:56 a.m., Acting Speaker, Chris R. Holden, 41st District, presiding INTRODUCTION OF BLACK HISTORY MONTH HONOREES

Assembly Member Holden, Acting Speaker and Chair of the California Legislative Black Caucus, introduced the Honorees of Black History Month and former Members of the Legislature: Hon. Yvonne Brathwaite-Burke, Hon. Cheryl Brown, Hon. Wilmer Amina Carter, Hon. Mike Davis, Hon. Isadore Hall, Hon. Elihu Harris, Hon. Nate Holden, Hon. Jerome Horton, Hon. Barbara Lee, Hon. Kevin Murray, Hon. Curren Price, Hon. Laura Richardson, Hon. Mark Ridley-Thomas, Hon. Sandré Swanson, Hon. Diane Watson, and Hon. Roderick Wright.

Each of the honorees received the 2017 Legacy Commemorative Award which was displayed at the Rostrum. The 2017 Legacy Commemorative Award recognizes the significant contributions made by the Members of the California Legislative Black Caucus to the State of California and its citizens.

Acting Speaker Holden welcomed distinguished guests present for today's ceremony.

#### PRESENTATION OF SPEAKER OF THE ASSEMBLY

Acting Speaker Holden then presented the Honorable Anthony Rendon, Speaker of the Assembly.

#### **SPECIAL RECOGNITION**

Speaker Rendon introduced the Honorable Karen Bass, 67th Speaker of the Assembly and United States Representative, representing California's 37th Congressional District; and the Honorable Willie Lewis Brown, Jr., 58th Speaker of the Assembly.

#### REMARKS BY THE SPEAKER

Speaker Rendon then addressed the assemblage:

Members, before I introduce this morning's keynote speaker, I want to do a couple of things. First, I'd like to acknowledge an outstanding leader of this house, former Speaker Karen Bass. It's a good thing for the people of California she is continuing to share her leadership in Congress.

I also want to take a moment to add my thanks and congratulations to all the members of the Legislative Black Caucus. For 50 years the Caucus has provided a strong, clear, and consistent voice for doing what is right and doing what must be done. I know your leadership will continue long into the future and be a positive force in many lives.

It is my privilege to introduce our keynote speaker. Of course, if it were not for term limits, there's a good chance he would actually be up here introducing somebody else right now. The longest-serving Assembly Speaker in California history, the Honorable Willie Lewis Brown, Jr., first came to the public's attention when he organized protests against housing discrimination in San Francisco. That commitment to civil rights has never flickered throughout his career—in the Assembly, as Speaker, and as Mayor of San Francisco. And, while we may not have the benefit of his being here with us in the Capitol every day, we still get to partake of his wisdom once a week in his *Chronicle* column. Mr. Speaker, the dais is—once again—yours.

#### **KEYNOTE SPEAKER PRESENTED**

Speaker Rendon presented the Honorable Willie Lewis Brown, Jr., 58th Speaker of the Assembly, whereupon he delivered the keynote address to the assemblage:

Mr. Speaker, thank you very much for your very kind words. I am unfamiliar with this space. You don't realize it's been 22 years now since I presided over this House and had the privilege of being able to only recognize whom I wanted to recognize, as their mics went up, and with the right, cut off mics appropriately. I am pleased, grateful, and honored that the Black Caucus led by Assembly Member Chris Holden and Assembly Member Shirley Weber would put together the kind of legacy program that they have put together for the 50th anniversary of the existence of the Black Caucus.

The Black Caucus started with six members: one State Senator; and five Members of the California State Assembly, which included one woman, Yvonne Brathwaite-Burke. As the world unfolded over the 50 years since the inception of the Black Caucus, two survive: Yvonne Brathwaite-Burke and I. The other original four members would be incredibly flattered and proud of what has come as a result of what they started. On behalf of Yvonne Brathwaite-Burke and my four colleagues who were the original founders of the Black Caucus, we say to the current members and the other members who have served in the Black Caucus, "Thank you." It's appropriately fitting that in the 50 years there have been 50 Members of the California Legislature, past and present, who come from the world of African America by heritage and by blood. That, in and of itself, is amazing.

The presentation Assembly Member Holden made on the resolution for Black History Month and the participation of those Members who rose to speak, whether it was the Speaker, Latinos, women, individuals reflecting the participation by African Americans in the development of this country, or as was the case with Assembly Member Weber, who gave such an incredible presentation, I just hope that every single solitary word, whether it was from the Jewish Caucus, the Women's Caucus, or the Latino Caucus, I hope it was all recorded and it would be made available to school children throughout the State of California. Black History Month represents an opportunity, as indicated by Dr. Weber, to pause and say what exactly was, and is the role of African Americans in the development of this nation.

I graduated from a little high school in Texas before Brown v. Board of Education and the Little Rock Nine. At that little school, which I graduated from in 1951, it was kind of interesting because we had history taught in the following way: You first had Negro history. No, that's not true. You first had Texas history, then you had Negro history, then you had U.S. history, and then you had world history. It didn't matter to your teachers if you only excelled in the second one, the most important, Negro history. Unfortunately, this nation didn't have Negro history because if this nation had been taught early on, and it was to this day a part of a curriculum, I'm speculating that the Black Lives Matter movement, the Panthers, or any of the other movements that have come about would, frankly not have been necessary. This country would have understood how awful this country's been to the people who provided more resources for the development of this nation than almost any other single ethnic entity in the development of this nation.

So when we pause once a year, one month out of the year, for Black History, it's really important that it be explored in great detail. Every single solitary component of how this nation evolved and how African Americans participated in the evolution of this nation should be provided, almost mandatorily. This nation is wrought with problems related to race as it has ever been. All of the references that have been made by single achievements, collective achievements, or movements, have not had the impact that has changed the nature of how this nation

exists and how it treats people of color: African Americans.

I witnessed yesterday, and you probably did too, the press conference in which the current President was asked a question by an urban journalist, a woman, a black woman, and she simply asked the question, 'At what point are you planning to interact with Congresswomen Karen Bass and Barbara Lee, and the 47 other members of the Black Caucus, people who serve in the federal government?" He responded by saying, "Can you arrange a meeting for me with them?" And she said, "With all due respect, I'm not sure that's a proper question to put to me. Yeah, I know, socially, one or two of them, but I'm a journalist. It's not my job to arrange meetings with other elected officials for you. But I'll certainly pass the word." That kind of a response from him is reflective of how America views people of color and in particular African Americans.

Being a Texan you know we got the message of the Emancipation Proclamation two years later. If you recall Abraham Lincoln did it in 1863 and it got to us on June 19th, 1865. They didn't have internet. They didn't have Snapchat. They didn't have Instagram. They didn't have Facebook. Many years after the Emancipation Proclamation, I don't think Texas has fully gotten it even today, because much of America has not fully gotten it, even today.

We are literally in the forefront. You are in the forefront. The legislative body of this state has always been on the cutting edge. I can remember clearly how, on a bipartisan basis, the efforts were made to get freedom in South Africa for the man who headed that nation but had been incarcerated for so many years. Assembly Member Maxine Waters, then on the Ways and Means Committee, cut a deal with Governor George Deukmejian which resulted in the anti-apartheid legislation that ultimately became acceptable throughout the world. The anti-apartheid legislation originated in this legislative body on a bipartisan basis between Assembly Member Maxine Waters and Governor George Deukmejian, a Republican. It freed Nelson Mandela. Barbara Lee actually represented the Legislature and went to South Africa for Election Day along with other colleagues from both the Senate and the Assembly, and of all colors.

You as a legislative body, with the Speaker's leadership, and the people that are following you, as well as the Members of the State Senate, represent something very special to those of us who are of color. You've had three African American Speakers in the history of this Body. Two are here today; one presides over the City Council of Los Angeles. You had a number of African Americans who have originated in this Body or in the Senate and ended up in Congress. Whether it was Diane Watson, Juanita Millender-McDonald, Maxine Waters, Karen Bass, you name it; you have come, and they came, as graduates of this incredible institution. This institution has afforded us the opportunity to help transpose this nation into a place where we all want to live, where we all want to enjoy every aspect of what James Weldon Johnson was talking about and what should be the national anthem of this nation. Each of its choruses carries on the hope and the inspiration that words ought to have. Unlike what we celebrate now as our national anthem, you can't do the second chorus of that anthem because it ventures into the reality of what this nation has been for so many years.

I applaud the Legislative Black Caucus for putting together the program that caused all of us, who've ever been here and who are alive, to either come back or want to come back to celebrate with you. I think it's the symbol of what the State of California and this nation so desperately needs. They had the Governor acknowledge it with his presence which represents just what it should be. Therefore, for Black History Month, you have now established a plateau. That plateau in pursuit of equal justice for all must be followed. I congratulate you. I thank you very much, and Godspeed.
