We once had a very well-intentioned board member who asked to meet with me. When we met, he was quite vocal critiquing a number of existing programs and projects being considered. I listened as he articulated the many issues that he felt were problematic. When he was done, I told him that he certainly had points worthy of consideration. Then I asked him, “What do you think we can do to make it better.” He shrugged his shoulders and said, “I don’t know.”

That’s when I realized again how easy it is to be a critic. It takes vision and courage to try to create something new. It takes care and effort to help improve a project or to keep a program moving forward. It takes no effort at all to criticize, for nothing is perfect. And all one needs to do is to see what’s not perfect and point it out.

Forty years ago, when I began working for Congressman Bob Matsui, I remember feeling diminished by criticism I received from an often-vocal coworker. His words were paralyzing for I became afraid of making a mistake. Fortunately, I had a brilliant mentor and friend who had recently retired from that same Congressional Office, Mary Amemiya. When Mary checked in with me to see how I was doing, I hesitated to share my feelings, but I did. Mary said to me with stern affection, “Patti, consider the source; and don’t let unproductive comments diminish you. It’s easy to be a critic.”

Mary’s wise words were always encouraging and empowering. And I will forever be grateful to have her fingerprints on my life. Let our words of counsel leave such fortunate fingerprints on the lives of those we touch.
