#### PRAYER

Upon invitation of Assistant Speaker pro Tempore Bauer-Kahan, the following prayer was offered by Assembly Chaplain Rev. Patti Oshita:

Please join me in a moment of reflection.

Today, we are remembering the results of Executive Order 9066, which made every man, woman, and child, of Japanese ancestry, regardless of citizenship, an Enemy Alien. This executive order arrested my parents and grandparents and incarcerated them, without due process of law, for the duration of World War II. My grandparents and my mother have passed. My father, who was drafted from the camp in Jerome, Arkansas, into the Army, and served in Germany and France during World War II, will be 97 this year.

My grandparents and parents came back from the prison camps—and make no mistake: they were in every way, prison camps for people of Japanese ancestry—they came back from these camps and rebuilt their lives, reestablished their communities, and instilled in their children and grandchildren, a deep sense of pride to be both Japanese AND American.

But most importantly, I am proud that, our country, the United States of America, is a nation that acknowledges mistakes made. And in having this Day of Remembrance, we are trying to ensure that our collective civil liberties will not be disregarded again. In observing this Day of Remembrance, we reaffirm our commitment as a nation, to continue our pursuit of "liberty and justice for all."
