PRAYER

Upon invitation of Assistant Speaker pro Tempore Celeste Rodriguez, the following prayer was offered by Reverend Bob Oshita:

In 1947, Primo Levi, a survivor of Auschwitz, wrote, “Monsters exist, but they are too few in numbers to be truly dangerous. More dangerous are the common men, the functionaries ready to believe and to act without asking questions.” Concentration Camps: Many might think this can’t happen in America. But it did . . . and it can again. In February of 1942, an Executive Order was signed depriving over 120,000 men, women and children of Japanese Ancestry, of their rights to “life, liberty, and the pursuit of happiness.”

I was born two years after the last of those of Japanese ancestry, incarcerated by that Executive Order, were finally released. Our parents and grandparents never talked about that traumatic time when entire communities were forcibly imprisoned. Never. While in college, many of my generation were trying to piece together the mystery of that unspoken time. In 1968, a few of us volunteered at a Japantown Senior gathering in San Francisco. We wanted to hear their stories of what was euphemistically called “Camp.” I knew these gentle elders had endured so much, but they would not revisit that painful time, nor share it with us.

Finally at one day, Mrs. Kiyō Hirano, who was like a Grandmother to me, pulled me aside and scolded me. She said, “Sono Camp no Hanashi wa mo Yamenasai!” (“Stop talking and asking about the Camps!”) She added, “Of course it was bad. Of course, we wish it never happened.” Then she said, “That is my pain and hardship; not yours. Don’t pick it up.” She warned me, “If you pick it up, it will poison your life.” She used the word “poison.”

Looking back, I realized that we, the generations that have followed, were given an amazing gift. We were given the gift of “no anger.” And on behalf of especially your children and grandchildren’s generations, we thank you.

Members of the Assembly: As required by the Budget Act of 2021, my office conducted an audit of the Local Jurisdiction Assistance Grant Program (Grant Program), and we generally determined that all cities and counties (local jurisdictions) that received funding from the Grant Program made progress in reducing the number of provisional licenses among their cannabis businesses, but we found that two local jurisdictions used some Grant Program funds inappropriately.

The 17 local jurisdictions that received Grant Program funds were able to transition about 1,200 provisional licenses to annual state licenses between January 1, 2023, and June 30, 2024. We project that if local jurisdictions continue to transition at the same pace, 12 local jurisdictions will have a few or zero cannabis businesses with provisional licenses remaining by January 1, 2026, after which most provisional licenses will not be effective. Further, although five local jurisdictions would have from 30 to more than 950 provisional licenses remaining as of the deadline, local jurisdictions and the Department of Cannabis Control (DCC) have taken actions to remove existing barriers at some local jurisdictions and believe that they will be able to help many cannabis businesses comply with local and state annual licensing requirements and transition by the State deadline.

Our review of selected local jurisdictions found that two jurisdictions—the city of Oakland and Sonoma County—did not always spend Grant Program funds in accordance with state law or their grant agreements. For example, Oakland used the Grant Program funds to help one business pay for its website and for another business to help pay its rent, among other expenses. Finally, although DCC hired four additional staff to manage the Grant Program, it continued to be slow in reviewing local jurisdictions' requests to amend Grant Program agreements. As a result, at least one local jurisdiction—Oakland—was not able to spend about \$1.9 million of its Grant Program funds.
