WHEREAS, In addition to his many other professional pursuits, Mr. Shapiro resourcefully found the time to teach as an Adjunct Law Professor at the University of Southern California's School of Law and remained a member of counsel for O'Melveny & Myers; and

WHEREAS, A gifted writer by nature, Mr. Shapiro worked as a staff writer for *The San Francisco Recorder* newspaper (7/87–7/90); as contributing editor for *The Ring Magazine* (86–89); Columnist for the *Los Angeles Daily Journal*, where he created and authored the "Malicious Intent" column (96–98); and continues to be a contributing writer for the *Los Angeles Times Book Review*; and he has received numerous awards, including the 1998 Western Magazine Publisher's "Maggie" Award for *Best Signed Editorial or Essay*; and

WHEREAS, Mr. Shapiro's notable work history includes that of the key role of Chief of Staff (12/98–4/2000), where he brought an extraordinary energy to the work at hand—an energy that inspired my staff and encouraged innovative advancement in many important areas that affect the quality of life for all Californians; and

WHEREAS, Mr. Shapiro was instrumental in kicking off the Lieutenant Governor's Commission for One California to improve race relations in our state; contributed greatly to efforts related to my *Contract to Fight Breast Cancer*; drafted inspiring speeches, such as the one I gave in the aftermath of the dreadful synagogue arsons—a speech which brought much relief and encouragement to the community; and

WHEREAS, As my Chief of Staff during many riveting and tumultuous events, Mr. Shapiro efficiently handled all of the important matters that arose, including the Amicus Brief for the landmark Proposition 187 situation; and

WHEREAS, Always looking to the future and in search of innovative ideas, Mr. Shapiro initiated the first international soccer cup event, with the intention of improving relations with our neighbors in Mexico; came up with the idea for the Lt. Governor's office to become proactive in Census count efforts—an idea that led to my membership on the United States Census Monitoring Board; hired staff and set up three offices to serve Californians; as well as handled outreach at the federal level; and

WHEREAS, Tirelessly pursuing new and demanding challenges,

Mr. Shapiro is currently devoted to his imaginative work as a staff writer for David E. Kelley Productions' popular television series, "The Practice," and has contributed greatly to the phenomenal success of the show; and
