Members of the Assembly: As required by Chapter 690, Statutes of 1997, the Bureau of State Audits presents its audit report concerning the status of community college districts' (districts) compliance with Section 84752 of the California Education Code that prohibits districts from receiving full-time equivalent student funding for activities that are fully funded through another source. This report concludes that although most districts appear to be complying with state regulations prohibiting the districts from requesting funding for such activities, the Chancellor's Office is not properly monitoring instructional service agreements (ISAs). As a result, the Chancellor's Office cannot assure that all districts receiving funds through ISAs have met state requirements for receiving state funds.
