SECOND READING OF ASSEMBLY BILLS**

ASSEMBLY BILL NO. 23—An act to amend Sections 1275, 1277.5, 4003, and 4004 of, and to add Sections 1277.1 and 1329.5 to, the Unemployment Insurance Code, relating to unemployment insurance, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.
