Dear Dotson: This is to advise you that I have made the following changes to Assembly Standing Committees in the Second Extraordinary Session, effective today, March 11, 2002:

#### **Appropriations**

I have appointed Assemblymember Darrell Steinberg to replace Assemblymember Carole Migden as Chair of the Appropriations Committee. I have also appointed Assemblymembers Rebecca Cohn, Manny Diaz and Marco Firebaugh to replace Assemblymembers Gil Cedillo, Helen Thomson and Herb Wesson.

Additionally, I have appointed Assemblymembers Gloria Negrete McLeod, Kevin Shelley and Carl Washington as members of the Committee, increasing the membership from 21 to 24 members.

#### **Business and Professions**

I have appointed Assemblymembers Marco Firebaugh and Helen Thomson to replace Assemblymembers Ed Chavez and Barbara Matthews to the committee. I have also removed myself from the committee, reducing the committee from 12 to 11.

#### Environmental Safety and Toxic Materials

I have appointed Assemblymember Dean Florez to replace Assemblymember Rebecca Cohn and Assemblymember Fran Pavley to fill the vacancy on the committee.

#### Governmental Organization

I have appointed Assemblymembers Wilma Chan, Rebecca Cohn, Jay La Suer and Ken Maddox to replace Assemblymembers Tony Cardenas, Herb Wesson, Abel Maldonado and Charlene Zettel. I have also appointed Assemblymembers Ellen Corbett, Carol Liu and Jenny Oropeza to the committee, expanding the membership from 20 to 23 members.

#### Health

I have appointed Assemblymembers Rebecca Cohn, Jackie Goldberg and Virginia Strom-Martin to replace Assemblymembers Judy Chu, Darrell Steinberg and Herb Wesson.

#### Housing and Community Development

I have appointed Assemblymember Darrell Steinberg to replace Assemblymember Rebecca Cohn.

#### Jobs, Economic Development and the Economy

I have removed Assemblymember Carol Liu from the committee, reducing the committee from 12 to 11.

#### Judiciary

I have appointed Assemblymember Ellen Corbett to replace Assemblymember Darrell Steinberg as Chair and Assemblymember Tom Harman to replace Assemblymember Robert Pacheco as Vice Chair. Assemblymembers Steinberg and Pacheco remain on the committee as members. I have also appointed Assemblymembers Rod Pacheco and Juan Vargas as members and have increased the membership of the committee from 10 to 13 members, leaving one vacancy.

#### **Revenue and Taxation**

I have appointed Assemblymember Ed Chavez to replace Assemblymember Ellen Corbett as Chair and have appointed Assemblymember Mark Wyland to replace Assemblymember Tom Harman as Vice Chair. Assemblymember Harman remains as a member of the committee. I have removed Assemblymember Paul Koretz from the committee, reducing the membership from 8 to 7; the membership to be consistent with the Regular Session.

#### Rules

The Committee remains the same.

#### **Transportation**

I have appointed Assemblymember Simon Salinas to replace Assemblymember Marco Firebaugh.

#### Water, Parks and Wildlife

I have appointed Assemblymember Joe Canciamilla to replace Assemblymember Dean Florez as Chair, Mr. Florez remains on the committee as a member. I have also appointed Assemblymembers Ellen Corbett, Lynn Daucher and Barbara Matthews as members, expanding the membership of the committee from 15 to 19 members.
