**ADDRESS BY SPEAKER-ELECT TONI ATKINS**

Thank you, Mr. Speaker. Thank you, all of you, for this honor and for the trust and confidence you've placed in me. I appreciate the thoughtful comments of my colleagues and I will work hard to live up to those words.

With appreciation and pride, I acknowledge you, Mr. Speaker, for your leadership and hard work these last 4 years. Going from all night budget sessions and a \$60 billion dollar deficit to the surplus of today couldn't have happened without your vision, leadership and political wisdom. We owe you our gratitude.

I want to also acknowledge our Minority Leader, Connie Conway, who frankly, has worked incredibly hard on behalf of her Caucus.

Together, our two leaders, Ms. Conway and Speaker Pérez, have set a respectful tone in this house, despite political and policy differences, that we would do well to emulate going forward. Thank you both.

We all want to be successful—Republicans and Democrats alike. We EACH came to this Chamber with the desire to serve our communities, our constituents, and to make a difference for California. We came from very diverse backgrounds, different political persuasions that run the spectrum of beliefs, and with our own life experiences that help give purpose and meaning to what we hope to accomplish. I believe in that endeavor for each one of us and I will strive my hardest every day to be mindful of that as we have individual and collective discussions that sometimes aren't easy or simple, or that rise to the level of serious disagreements (and that's just on the Democratic side!).

I have learned in my time in the Assembly and in my quest for the Speakership how much I truly and deeply respect each of you, this institution, and the job before us.

California is a nation-State. We have important and critical issues before us:

- Our water crisis and our overall water plan and infrastructure.
