Dear Dotson: I am writing to create a subcommittee of the Appropriations Committee. The Subcommittee on Infrastructure Finance will be chaired by Assemblymember Robert Hertzberg, and have the following members: Assemblymember Bill Campbell, Assemblymember Bob Margett, Assemblymember Carole Migden, Assemblymember Darrell Steinberg, Assemblymember Helen Thomson and Assemblymember Roderick Wright.

*Legislative Management of Infrastructure Is a High Priority.* The Department of Finance estimates that the state needs to invest \$82 billion in capital between 1999 and 2009. Finance has identified funding for about half of this capital inventory. As a result, the state faces a \$40 billion capital deficit. Assuming this deficit will be financed primarily with bonds, the Legislature must secure the passage of bond proposals averaging \$8 billion, in *each* of the next five election cycles.

In crafting these bond proposals, the Legislature must ensure that the state's capital needs are met cost-effectively. It must also balance the state's economic, environmental and growth goals.

*The Subcommittee to Develop an Overall Approach to Capital.* The Subcommittee will have the following responsibilities:

- Hear all legislation dealing with capital outlay and public infrastructure.
- Provide oversight on state infrastructure finance.
- Consider the bills which would place bonds on the primary and general elections in 2000. The Subcommittee is charged with developing a balanced package of bond proposals.

The Subcommittee will work in concert with the recently appointed Governor's Task Force on Infrastructure.
