PRAYER

Upon invitation of Speaker pro Tempore Lieber, the following prayer was offered by Guest Chaplain Rev. Monsignor Eugene J. Boyle, Retired Pastor, Diocese of San Jose:

I was closely associated with Cesar Chavez as friend and confidant from the day I first met him in 1966 during the March from Delano to this State Capitol—a Peregrinacion (a pilgrimage) he called it—until his death in Arizona on April 23, 1993.

I dare to say the prayer that I believe Cesar would be substantially uttering with you this day:

O God, You have gifted us with the beauty and challenge of this new day. For this we are thankful!

You have brought us into the company of people, who, bound strongly together in the union of brotherhood and sisterhood, are striving to join their efforts with Yours and to extend the full measure of justice, equality and freedom to all. The evidence of Your presence in the midst of this gathering of the caring and concerned is palpable. For this too we are grateful.

Strengthen in us, O Lord, the conviction that effective labor unions, like ours, the United Farmworkers of America, AFL-CIO, are by far the most powerful force in society for the achievement and protection of workers' rights and the improvement of their conditions; that no amount of employer benevolence, no campaign to achieve a sympathetic attitude on the part of the public, no increase of beneficial legislation, as helpful as all these are, can adequately substitute for organizational efforts on the part of workers themselves to achieve a living wage, adequate benefits, especially health insurance and decent working conditions. Never let us forget, O Lord, the word of Pope John Paul II that labor unions are indispensable in modern industrial society and enable us to spread that word far and wide.

We pray, Lord, for all who are deprived of the benefit of union and have to live in poverty—the hungry, the homeless, the immigrant, the working poor in our midst, and all who lack adequate health care. We pray that You awake us to the realization that we all have a vital stake in closing the swelling income gap between the more affluent in our community and the low-paid contingent worker with no job security, no benefits, no health insurance and only the most precarious tomorrow.

We pray for those of Your people who are without legal rights, who are despised and maltreated because of the color of their skin, the tenets of their creed, or orientation of their sexual preference. We pray not only for those who suffer these injustices, but also for those who foster and increase them.

We pray, Lord, for the world today racked with violence and threats of violence. Give us the strength to break this vicious spiral first, in our own hearts, and then in the world around us.

We pray for those who are broken and crippled by violence, exile and war. We pray that a way to peace will continue to be pursued in the Middle East. And we pray especially for the safety and well-being of our service men and women in these troubled countries.

Give us all the wisdom and strength of Your spirit and help us to continue to call forth leaders from among us, on the local and national level, who will ever remind us of what makes for a just and peaceful society and contributes most surely to the common good.

Above all, make us gentle and forgiving and be Yourself merciful to us. Teach us to pardon one another and give us the strength to be compassionate.

You have given us life, this day, this company. Make us always ready to share with others so that the joy and happiness and achievement we experience this day may be the joy and happiness of all forever.—AMEN.
