In 1952, Cesar Chavez began participating with the Community Service Organization (CSO). CSO was a grassroots, door-to-door organization for social change. During the 1950s, he helped develop 22 new CSO chapters in the Mexican-American neighborhoods of San Jose. In 1959, Cesar Chavez became the National Executive Director for the Community Service Organization.

His goal for the CSO was to eventually organize a union for farm workers. In March of 1962, when the CSO rejected his proposal to create a union for farm workers, he responded by resigning from the organization. That same year, Cesar Chavez and Delores Huerta would become co-founders of the United Farm Workers union.

The human spirit is truly resilient; and given a just cause and visionary leadership, our national history has shown that human decency will continue to prevail.
