Governor, Mr. Speaker, Members, relatives and friends, it is indeed most fitting that we pay tribute this evening to an extraordinary individual whom we came to know and love, Marco Antonio Firebaugh.

I want to begin my comments this evening by reading a poem written by George Bernard Shaw, because I believe it epitomizes our friend Marco Firebaugh.

“This is the true joy in life, the being used for a purpose recognized by yourself as a mighty one; the being a force of nature, instead of a feverish, selfish little clod of ailments and grievances complaining that the world will not devote itself to making you happy.

I am of the opinion that my life belongs to the whole community and as long as I live it is my privilege to do for it whatever I can.

I want to be thoroughly used up when I die, for the harder I work the more I live. I rejoice in life for its own sake.

Life is no “brief candle” to me. It is a sort of splendid torch, which I have got hold of for the moment, and I want to make it burn as brightly as possible before handing it on to future generations.”

Our friend Marco leaves us a powerful legacy. A legacy based on his core values of inclusion, of tolerance, of equal access and opportunity, and the core value of justice for all.

As you know, Marco was a very determined individual. He was extremely passionate, very caring and very giving to others.

Marco exemplified the hopes, the dreams and aspirations of millions of people who dare to dream, who dare to make a better life for themselves and their family and who dare to make that journey to this great country of ours, the United States of America. Marco had the burning desire to tear down the walls that stood between immigrants and their dreams.

At the age of one, Marco’s family moved from Tijuana Mexico, to San Diego. Marco became a naturalized citizen with the determination of getting the best education that California offered. And he did.

Marco saw a future in California where every child had a right to an education.

To Marco, children were non-negotiable.

He believed children deserved to be educated; he believed children deserved health care; and he believed children should be protected from second hand smoke while in the car.

Marco believed that through the education of its people, California could become more accepting, more tolerant and respectful of the different cultures and the contributions that made California the greatest state in the nation and the sixth largest economy in the world.

The torch has been passed on to generations to come. And despite our loss and our grief, Marco's hunger for justice lives on as evidence by the largest march in the history of Los Angeles supporting immigrant rights, their dreams and supporting justice for all.

Marco made a difference in the lives of people and because of that, his spirit, his love, his smile, his sense of loyalty and the core values he carried, will be our inspiration in keeping his legacy alive.

I do remember the house I promised you oh so many years ago and I hope you are not disappointed because you are the spring of all my hopes, “my rock of Aztlan.” In you and my siblings I find the strength to fight on, the love of life and the importance of my task ahead.

May you be truly happy on this day. You and the others remain the most important part of my life.

Good afternoon. My name is Carlos Diaz, brother of Marco Firebaugh.

On behalf of my family, I would like to thank Speaker Fabian Núñez, Senator Don Perata and the California Legislature for paying tribute to my brother, Marco Firebaugh.

Marco was in many ways the head of our family, the one who always inspired us to better ourselves and to lend a helping hand to those who were struggling to reach their goal.

Marco always encouraged us to educate ourselves in order to better our lives and the ones around us. Education was very important to my brother.

He believed that everyone should have the opportunity to reach their educational goal. He has passed along that very passion to my younger sister who is pursuing her master's degree in Social Work.

Over the past year and a half I had the opportunity to work with Marco for his consulting firm. While working at MAF I saw another side of my brother that most of our family never had the privilege to experience.

I was able to sit in board meetings with him. I would see first hand my brother at work. I was always amazed how he worked the crowd. He had this way of making people feel very comfortable.

I worked very close with him and our clients strategizing our next move. I also walked precincts with him during the special election. I could feel how strong he felt about politics and I could finally relate to his passion for positive social change.

I never realized how important my brother was until I had the opportunity to work with him. I saw the way people followed and respected him. To me he was always my older brother. He never demanded special treatment from us or acted like he was more important.

He was the Marco who loved Mariachi, enjoyed a good tequila and always asked Mom for frijoles when he would come from Sacramento.
