Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the Board of Equalization's (board) audit program of the sales and use tax. This report concludes that the board's audit revenues fell \$123 million short of projections after it received an additional 250 auditor positions. A principle cause of the shortfall was that audit effort is still at the same level it was before the increase. In part, this is due to the board's decision to deploy over half of the additional positions to support functions. Also, the board's revenue projections contain several flaws, such as not factoring in lower revenues for new auditors and overestimating the average number of hours its staff directly charge to audits.

In addition, the board provided accurate information in its response to the Legislature's request. However, the request did not require the information necessary to analyze the benefit from the additional positions.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the effectiveness of the State Personnel Board (board) in managing disciplinary hearings. This report concludes that the board has improved the time it takes to resolve disciplinary appeals and has streamlined its efforts on these appeals. However, further efforts are needed to improve the time it takes to resolve other employment-related appeals and reduce workload on some disciplinary appeals. Several factors contributed to delays in processing appeals, including staffing deficiencies, a vacant management position for 16 months, an inadequate caseload tracking system, and outdated workload standards and strategic plan. Finally, this report concludes that overall, appellants do not appear to be dissatisfied with the board's fairness in handling appeals.

Dear Mr. Speaker: I respectfully request that we adjourn in the memory of Wilson C. Riles, who, in three terms as Superintendent of Public Instruction, guided California's education policy between 1971 and 1983, implementing several successful breakthroughs in special education and encouraging greater parent participation in curriculum decision. When he became Superintendent in 1970, he was the first African American elected to statewide office.

Born into poverty in Louisiana, his family moved to Arizona after his high school days. Wilson Riles graduated from Arizona State Teachers College and served in the Army during World War II. He returned to Arizona State for his Masters Degree before moving to Los Angeles in the early 1950s. In 1958 Riles began his tenure with the Department of Education, working as director of compensatory education in 1965 and, in 1969, becoming Deputy Superintendent in charge of Special Education under Superintendent Max Rafferty.

In 1970, Wilson Riles challenged Rafferty for the Superintendent's position. The campaign offered Californians a clear-cut choice in education philosophy: Rafferty's emphasis on basics vs. Riles' progressive education focus. Wilson Riles' approach prevailed with the electorate as he won his first of three terms.

As Superintendent of Public Instruction from 1970 to 1982, Riles was able to attract greater federal support of California's Early Childhood Education program. He also worked to provide schools as much state support as possible in the days following the implementation of Proposition 13. In recent years, Riles continued his education involvement through his consulting firm that he ran with his son. The Sacramento and Grant school districts hired him to recommend district superintendent candidates. An imposing figure, Wilson Riles cast a long shadow over California's education that will continue well into the next century.

Mr. Speaker, I respectfully request unanimous approval that we adjourn today in the memory of former Superintendent of Public Instruction, Wilson Riles.
