We must do our part in filling the void of goodness and spirituality that was left by the Holocaust, one Mitzvah at a time. In doing so, we will bring the world closer to the fulfillment of Isaiah's prophecy, which we read on the last day of Passover, "They shall not hurt nor destroy in all my holy mountain; for the earth shall be filled with the knowledge of God, as the waters cover the sea."

May this take place speedily in our days.—AMEN.
