In Memoriam

I ask that we adjourn in memory of Carole and Juliana Sund, whose tragic deaths while on vacation in Yosemite saddened my district, the state, and the entire nation.

Carole Sund, a 42-year-old mother of four from Eureka, California, brought her daughter Juli, 15, and 16-year-old Argentinian exchange student, Silvina Pelosso, to Yosemite National Park. While on vacation, the unthinkable happened and their lives were tragically and maliciously taken from us.

In honor of the women whom I had the privilege to represent, I ask that you give me a moment to share their lives and achievements with you.

Born and raised in Sonoma County and educated at the University of San Francisco, Carole Sund worked in the real estate field and became a full-time mother to four children. Carole dedicated herself to many community causes and organizations. Most notably, Carole worked to assist abused children. She helped form Court Appointed Special Advocates (CASA) in Humboldt County to advocate for children through the court process. She was also an active member on the Council on Adoptable Children and volunteered as a foster parent. In addition, she served as a member of the Service Review Team through the Department of Welfare, which reviews cases and decisions regarding placement of children. Even with all these activities, Carole kept involved in her children's education, volunteering in their elementary classrooms.

Her daughter, Juli Sund, was born and raised in Humboldt County. A Sophomore at Eureka Senior High School, she was boisterous, fun-loving, and eager to try new experiences without fear of failure. An avid music-lover, she played the piano, violin and guitar. Also important to Juli was cheerleading, camping and the outdoors.

Carole and Juli will be dearly missed by their family. They are survived by husband and father, Jens Sund; sons and brothers, Jimmy and Jonah; daughter and sister, Gina; and their parents and grandparents, Francis and Carole Carrington.

Their many friends and the entire Humboldt community will truly miss them.

I ask for a moment of silence in honor of Carole and Juli Sund.
