A most frantic moment became one of surprise and relief. You can imagine our disbelief and our gratitude. But deeper still, we felt assured that honesty, integrity, and kindness actually do exist in this world; a world that at times, seems so blinded by selfishness and greed.

It was not just Bob’s wallet that was returned that day. In realizing that such decency does exist, we were gifted a renewed hope in humanity that we did not realize we had been losing.
