Dear Speaker Wesson: It has come to my attention that a question has arisen regarding the language of AB 1258, and whether it purports to alter pre-existing California law as to whether rental car companies may rent, for in-state use, cars that are registered in other states under certain circumstances. I am submitting this letter to the journal, which clarifies the legislative intent of AB 1258.

AB 1258 was an urgency bill that provides a safe harbor until January 1, 2002 from *all* California provisions regarding the in-state use of rental cars registered in other states, under certain circumstances. It was not my intent to permanently alter existing law as to whether rental car companies could rent, for in-state use, cars registered in other states.
