SENATE BILL NO. 3—An act to amend Sections 100501 and 100503 of, and to add Sections 100504.5, 100504.6, and 100504.7 to, the Government Code, to amend Section 1366.6 of, and to add Section 1399.864 to, the Health and Safety Code, and to amend Section 10112.3 of, and to add Section 10961 to, the Insurance Code, relating to health care coverage.
