### **PRAYER**

Upon invitation of Speaker pro Tempore Keeley, the following prayer was offered by Assembly Chaplain Rabbi Mona Alfi:

From sunset this evening through sunset tomorrow, Jews around the world will be observing Yom HaShoah—Holocaust Memorial Day. As we remember our own losses we look across the ocean and are chilled by the specter of the past that seems to have come alive once again.

Elie Wiesel, the noted philosopher and writer, and survivor of Auschwitz and Buchenwald, spoke these words about the Holocaust when he received the Nobel Peace Prize in 1986:

"The victims perished not only because of the killers, but also because of the apathy of the bystanders. Those who perished were victims of Nazism and of society—though to different degrees. What astonished us after the torment, after the tempest, was not that so many killers killed so many victims, but that so few cared about us at all."

Two generations of Jews have been raised with the watchword "Never Again".

"Never Again" does not mean never again to us, to the Jews. It means "Never Again" period. Never again shall any people watch idly by while another people suffers from injustice, persecution, torture, exile, and mass murder.

The lesson of the Holocaust is that we live in an interconnected world, and sometimes apathy can become evil's most potent tool.

May the Holy One of Blessing grant us the ability to confront evil in its many guises, even when we ourselves are not threatened. May we have not only the capacity to have compassion for all of God's creatures, but may we also have the courage to act on that compassion.—AMEN.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning whether recent budget increases for the Department of Corporations (department) led to improvements in the protection of consumers of health care service plans (health plans). This report concludes that despite a budget increase totaling \$6.5 million, improvements have been limited. For example, although results of the department's enforcement and complaint resolution functions show some recent improvement, results of other functions do not. Specifically, consumer protection was less than expected because the department had not completed by December 1998 nearly half of all required medical surveys. Similarly, consumer protection was less than expected because the department had a modest backlog of one type of financial examination. Further, as of March 5, 1999, more than 200 complaints from consumers were still open even though the

department had exceeded the statutorily required 60 days to resolve complaints. We believe that the primary cause of these weaknesses is inadequate management.

We also determined that, during fiscal years 1996–97 and 1997–98, the department did not spend substantial portions of its budget allotted for health plan regulation. Since the largest single source of revenue for such regulation is assessments collected from health plans, large balances at year end result in health plans paying more fees than necessary for the costs of the regulation actually provided by the department.

Members of the Assembly: As requested by Chapter 324, Statutes of 1998, the Bureau of State Audits presents its audit report concerning the Department of Health Services' (department) operation of its port of entry Medi-Cal fraud detection programs, Port of Entry Detection (PED) and California Airport Residency Review (CARR).

This report concludes that the department's operation of the PED and CARR programs is no longer justified. Although the department recently modified its procedures for the programs in response to lawsuits and federal government concerns, the modifications significantly diminished the cost-effectiveness of the PED and CARR programs. Consequently, the department is no longer recovering enough payments to justify its investment in the programs. Thus, the State and the Medi-Cal program would be better served if the department redirected its investment to other fraud detection programs that more effectively prevent or recover fraudulent payments.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its report concerning the extent to which physicians and medical groups believe they receive late payments for their services and the effect any delays may have on their practices.

Based on the results of our surveys, this report concludes that 51 percent of physicians and 74 percent of medical groups report problems with some kind of delay in payments for their services. Fee-for-service payments from independent practice associations (IPAs), preferred provider organizations, and point of service plans came in for the most criticism from medical service providers. Twenty-eight percent of the physicians and 38 percent of the medical groups responding to our survey claim that delays negatively affected the fiscal aspects of their practices. However, few reported that delays affect their patient care.

In contrast, health plans and health care intermediaries report few payment difficulties and report that they receive and make most payments within reasonable time frames. Medical groups, IPAs, and management services organizations expressed concerns over the accuracy of the enrollment data on which capitation payments are based, as well as some problems with health care plans' distribution of risk pool moneys. The survey results have implications for California's regulatory structure over its health care industry. In particular, some health plans and intermediaries are either indirectly regulated by the State or not at all.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the operations and management of the California Science Center (science center) and its relationship with its auxiliary, the California Science Center Foundation (foundation).

This report concludes that although the State is the science center's primary benefactor, it relinquished governance of the science center to

the foundation. Specifically, while the State has historically controlled science center policy, management, and operations, these functions are now primarily under foundation direction. Further, we noted that state-appointed executives, who also serve the foundation in some capacity, are not properly protecting the State's interests in the science center and Exposition Park. This is due in part to a series of decisions that these executives made and actions they took, which favor the foundation's interests, particularly in matters of potential conflict between the State and the foundation. Finally, and perhaps as important, the science center's administration has also failed to operate in a fiscally responsible and legal manner in other aspects of its operations.

### In Memoriam Tom Bane

Assembly Member Papan was granted unanimous consent that when the Assembly adjourns on this day it do so out of respect to the memory of Tom Bane, former Member of the Assembly (1958–64, 1974–92), former Chairman of the Committee on Rules and Assistant Speaker pro Tempore, (1978–86), died Saturday, April 10, 1999, at the age of 85. Mr. Bane had been suffering from poor health for several weeks and died at Encino Hospital.

Tom Bane, Democrat—40th District: Born and raised in the San Fernando Valley area of Los Angeles County, he worked as an insurance agent and was first elected to the California Legislature, in 1958, serving 3 terms in the State Assembly, (1959–64); and elected Chairman, Assembly Rules Committee. Re-elected to the State Assembly a second time in 1974, (1975–92), Tom Bane was elected Assistant Speaker pro Tempore in 1978 under the Speakership of Leo McCarthy. His legislative career in the State Assembly lasted over 22 years, (1958–64, 1974–92), and spanned five decades of political life.

Tom Bane, made an unsuccessful bid against Republican Ed Reinicke to represent a westside Los Angeles congressional seat during the general election in November 1964.

Tom Bane sought re-election to the State Assembly in June, 1974 successfully facing seven Democratic primary challengers and was elected by a two-to-one majority in November, 1974 to represent the San Fernando Valley constituents of the 40th Assembly District. He served 16 years during his eight terms in the State Assembly, (1975–92), and was elected the Assistant Speaker pro Tempore, (1978–86).

During the 22 years of service as a legislator in the California State Assembly, (1958–92), Tom Bane's long history and impressive accomplishments span across a political era covering five decades. He served as the Chairman, Committee on Rules; and served as a Member, Committee on Elections, Reapportionment and Constitutional Amendments; Finance, Insurance and Commerce; Governmental Organization, Housing and Community Development. Served as the Chairman, Governmental Organization Subcommittee on General Services Contracting Policies; and Chairman, Finance, Insurance and Commerce Subcommittee on Unemployment Disability Insurance.

Tom Bane founded the California Constitutional Revision Commission, served as Chairman to prestigious organizations like the National Lupus Foundation, the March of Dimes, American Red Cross, Community Chest, American Jewish Committee, and YMCA; and was a member, Foundation for Junior Blind, and received the Geri Award for "Outstanding Service" to senior citizens; member, Veterans Service Center Board; and Recipient, of Television (Ch 11's) Special Award for "Someone Who Cared".

Tom Bane was born on December 28, 1913 in Burbank, California and spent the majority of his long life residing in the San Fernando Valley. He leaves behind his beloved wife, Marlene, (Reseda, California); two sons, Bruce and Neal; and 8 grandchildren.

Memorial services will be held at 1 p.m., Wednesday, April 14, 1999 at the Eden Memorial Park, located at 11500 Sepulveda Blvd., Mission Hills.
