It is with a special sense of pride and joy that I'd like to introduce my wife, Corina.

And, I would like to introduce someone else who is very close to my heart—my son, Antonio Villaraigosa.

Antonio is here today with his teacher Lucy Hunt and his class from Mt. Washington Elementary School.

Antonio, it is important that you are here, today. You were here with me, when I was first elected Speaker, two years ago.

I still remember the look of apprehension on your face when the vote count was taking place.

And the relief you showed when I was actually elected Speaker.

I know the pride you have for me. And, I want you to know that it is more than matched by the love I have for you.

I'm especially pleased that you and your classmates are here today to witness what a transition of power should look like in a democratic society.

There have been some bumps along the way, of course. But, for those who remember—this changing of the guard of the Speakership used to be less a passing of the torch—than a burning of the city.

I believe that at the end of the day, Antonio, and our new Speaker's sons—David, Daniel and Raymond—can all be proud of what happened here.

As I said on January 24 of this year—when I placed Bob's name into nomination as the next Speaker of the Assembly—I am gratified to pass the torch of leadership to him.

I believe Bob will prove to be an exemplary Speaker. His leadership is fired by the passion he has for improving the process of government.

I think we've all seen this passion . . . and his sincere desire to make this Assembly work more efficiently for the people of the state.

He deeply cares about the people we serve. I know of some of the challenges of this job, and I feel he has all the talent and skills to meet them—and more.

I feel secure in knowing that I leave the care of this Assembly in his capable hands.

I also feel comfort in knowing that Bob is committed to carry on what I hope will stand as a legacy to my tenure here.

That is the unprecedented atmosphere of collegiality and bipartisanship that we've established within these halls in the past two years.

We brought back civility and respect to the debates and actions on this floor.

I also want to acknowledge the Republican leader, Scott Baugh, for your great efforts and willingness to work together.

I hope that we have established a model for the future of the Assembly under term limits that will endure beyond our years here.

Finally, I want to thank you, Members, for extending to me the distinct privilege and honor of serving you as Speaker, for the past two years.

You afforded me an experience I will always treasure, and an opportunity I can never forget.

I think we all agree California is poised at the threshold of an exciting future. And, I believe each of us has a role to play in shaping that future.

But, these past two years will remain unique and special in my heart as a time we were able to make government work, by working together.

And so, I want to thank you again, for this extraordinary experience.

There is just one last thing I would like to say as the 63rd Speaker of the California State Assembly:

Address by Speaker Hertzberg

- And, finally, to my wonderful staff—who put their hearts into their jobs. I am forever grateful.

My friends, there's glory in these walls. For 150 years, the State Assembly has been the place where men and women from all over California—from different backgrounds and different walks of life—have come together to solve problems—plan California's future—and stand up for hard-working Californians.

We all come here with different beliefs about what should be done for this great state—and different ideas about how it should be done.

But despite these differences, we have all come here for one reason: fundamentally, all of us—all of us—share a deep concern about our state's future and a compelling desire to make a difference for her people.

For this reason, it is incumbent upon us to respect each other for fighting hard for the communities we represent, and yet, at the same time, seek the common ground necessary to create a vision and plan for California's future.

And what a glorious future it could be!

As we all have witnessed, every day, dignitaries from all over the world visit this Capital to witness the genius of California.

They come to see our incredible economy. They come to understand what makes our state the global leader in entertainment and invention, technology and trade. They seek us out as a model of democracy and diversity.

In fact, no where else on earth do more diverse communities come together to live and work.

With the eyes of the world looking towards us, we are, in my judgment, at the threshold of a defining moment.

It is a time of unparalleled economic prosperity and a time of brilliant financial growth. Yet, it is a time of increasing economic disparity, vast unmet needs, and a gaping infrastructure deficit.

There has never been a time in our recent history of such unique opportunities and such colossal challenges.

This is a moment crying out for dedicated, creative leadership that transforms sheer change into real progress.

Republican Leader Scott Baugh and I share a goal—this is the time to do “something *great* for California.”

But, let's not kid ourselves, today we are facing a real problem. Out there—beyond the rooms where the deals are made, far away from the halls of power—many hard-working Californians no longer believe that what we do here—really matters.

They don't believe that we're looking out for their best interests. In fact, they don't believe that government works—and they certainly don't believe it works for *them*.

It is time we gave Californians faith in their government again. We must show that we are solving real problems, and that we are working hard for those who are working hard. That's our job.

Here's how I believe we should do it:

First, we should put aside our squabbles and pour every ounce of our energy into finding solutions that work—for *all Californians*.

That doesn't mean any of us should give up our beliefs. When we disagree, let's get the issues out on the table and hash out our differences.

Let's park our egos at the door, reach decisions, and get things done.

Second, let's make sure that *all* Members get every opportunity to rise to the occasion and give this great state their very best.

In part, that means providing us with the best possible information, resources, and, most importantly, training to do our jobs.

Our success in terms of schools for legislators and staff has been a product of both parties working together.

And if you will permit me a point of personal privilege, ladies and gentlemen, today I'm pleased to announce that a classroom at the newly-created Capital Institute will be named for our colleague, former Republican Leader Bill Leonard, who has been essential in making our program a reality.

Third, when we pass a law, we need to have oversight.

- Is the law doing what it is supposed to do?
- Are the bureaucrats providing the best possible service to the public?
- Is the executive branch implementing our vision of the laws that we write?

And I know that the Governor is just as interested in oversight as we are.

When services fall short, it's hard working Californians that get hurt the most—and that is just not acceptable. If we want Californians to have confidence in us again, we have to get it the old fashioned way—by earning it.

That is why, today I am announcing that we are establishing an Office of Oversight which will report directly to me.

Fourth, we have to create a new culture in our institution that embraces technology—with the ultimate goal of better serving our constituents and creating greater access to government for every Californian.

We need to bring the voice of the people into this chamber. That's why I think we should move towards the day when every bill has its own web page—with a chat room where Californians can make their ideas heard.

Fifth, we need to pass smart new laws to keep up with the dynamic changes sweeping the state. But we need to do more.

We need to show that government can both add and subtract. That we can get rid of old laws that are out-of-date and out-of-touch with the new California.

Sixth, and finally, we need to plan for the future. That's why our thinking has to go beyond the next budget cycle and look 5 and even 10 years ahead. We have to look down the road—and not just play catch-up.

As your new Speaker, I pledge to provide the kind of leadership that encourages us to do all these things—to spend our time finding solutions for California and not losing sight of what we were sent here to do.

I pledge to support a culture that honors each member of this House as an individual—a member of this House first, and a member of his or her own party—second.

I have spoken about the opportunities and challenges we face and about how we should approach our work.

Now, I would like to make some brief remarks about the goals that I believe are important for us to undertake, understanding clearly that everything we do in this House is a collaborative effort, with each of us having a responsibility to our own independent perspective and conscience.

In everything we do, I believe that one fact forms the foundation for our work: California is changing. We are at the dawn of a New Economy that will completely transform the way we work and live. California is ground zero for the New Economy. I am convinced that we have to embrace it.

But first, we have to understand it. The New Economy is found in places where entrepreneurs and innovators are creating jobs and changing the world. But it is found in other places too.

The New Economy is the auto mechanic who works on cars with more computing power than the capsule that took Neil Armstrong to the moon.

The New Economy is the farmer using satellite mapping to grow better and stronger crops.

The New Economy is the small, San Fernando Valley multimedia firm whose creative use of technology entertains and informs people around the world.

The New Economy is the nurse using advanced diagnostic technology to get patients on track for recovery.

The New Economy is the labor union that provides training for its members—who need to compete and win in a global marketplace.

The New Economy is all the workplaces that have broken down the old hierarchies and given workers a greater voice.

We have to be on the side of the New Economy—making sure that its promise reaches every Californian.

But let me be clear: as we embrace the New Economy, we must never forget our fundamental values.

Though there are more billionaires than ever, there are still far too many Californians stuck in a cycle of poverty and still far too many

who, in spite of working their guts out, are not able to get ahead.

- We should never stop fighting for social justice.
- We should never stop reaching out to those who are being left out.
- We should never stop helping those who are getting left behind.

There will always be those Californians who don't have powerful interests on their side. It is up to us, in my judgment, to stand up for them and provide common-sense solutions to the issues they face every day of their lives.

That is why we should prioritize affordable housing in the places where economic growth is taking off with incentives to local governments.

We should support efforts to cut down commute times by connecting jobs and housing together—helping people work where they live and live where they work.

We should do everything we can to promote child care for working parents.

We should find creative answers to Information Age questions like privacy and Internet taxation.

We should provide better services for the mentally ill, so that they get adequate treatment and instead—do not end up homeless or behind bars.

We should take new, creative steps to ensure Californians have access to quality health care.

Finally, in the 21st century, education *is* infrastructure. We must make an investment in the minds of Californians a top priority. It is an embarrassment that in a state with the plenty of California, we invest less in our schoolchildren than all but a handful of other states.

I want to commend the Governor for his comprehensive education proposal. And I believe we should supplement it with more help for those students with the greatest need.

I believe it is time that we connected schools to their neighborhoods by combining them with community centers.

I believe in building smaller schools where kids are less likely to fall through the cracks.

I believe in valuing education enough to show that we *value teachers* and the nobility of the teaching profession.

I want to cut through the state's bureaucratic red-tape so that local communities have more control and less paperwork.

And I will work to strengthen our community colleges because, for Californians of all ages, they are the true classrooms of the New Economy—where we are training the nurses, technicians, and computer analysts we need.

Not all of the challenges Californians face will be solved through legislation. We live in a high-pressure, fast-paced, hectic world.

Television and traffic. Car alarms and dead bolts. Taking care of our children and parents. We don't know our neighbors—and our kids' friends live across town. The values we share and the duties we owe to one another sometimes get ignored.

The balance between rights and responsibilities, between opportunities and obligations, sometimes gets forgotten. The bonds that tie us together sometimes get frayed.

But nevertheless, I believe that we can make a difference. By our actions here, we in the Assembly can show the whole state that there is a better way. That people with different views and different experiences and different backgrounds can come together, forge a common ground, and work towards the common good.

We won't always agree, but we must always remember why we are here—to achieve results for the people we represent.

Solving problems, planning for the future, fighting for every Californian, calling out the best in *all* our people.

That's the true meaning of the oath I have sworn before you and before God. That's the job we have before us.

Now, let's go to work. Thank you.
