We pray to the Almighty God to empower the members of the California State Assembly to be dedicated leaders in guiding the people entrusted to them with the lessons of the past, enriching the present with a deeper sense of responsibility to honor life, and with the vision and the humility to lead us to a brighter tomorrow for the sake of our children.—AMEN.
