In the face of barriers encountered while attempting to guide their destiny, four intrepid men formed the Cortez Growers Association on April 18, 1924. Yonekichi Kuwahara, Nenokichi Morofuji, Seitaro Yoneyama, and Zenshiro Yuge formed the nonprofit corporation to overcome prohibitions against alien land-holding and difficulties encountered in dealing with a culture very different from their own. Within a year, membership had grown to eleven, a packing shed was built, a well was sunk, and a telephone installed. Crops grown by the Association included peaches, carrots, eggplant, strawberries, walnuts, and onions.

The Cortez Growers Association prospered for seventeen years, helping its members and the surrounding community weather the bleak years of the Great Depression. Then, on December 7, 1941, news was received of the bombing of Pearl Harbor. By May of 1942, the farming families of Cortez had been removed from their homes, placed in internment camps, or sent to fight in the European Theater. With great forethought, the members of the Association had placed their operations in a trust that kept their farms intact with tenant farmers.

Following the war, the families returned to Cortez and, on February 1, 1946, brought the Growers Association back to life. While the

immediate post-war years were difficult, the people of Cortez persevered and prosperity returned. Association membership has increased and diversified as have the number and types of crops grown. Innovation has become the hallmark of the Cortez Growers Association and this trend continues today with the development of new technologies and procedures.

The future holds promise for the farming families of the Cortez Growers Association because of the commitment of the membership and the ability of a dynamic board of directors and management to quickly adjust to ever accelerating change. With this letter we commend and honor the Cortez Growers Association and wish them continued success.
