#### **PRAYER**

Upon invitation of Speaker Pérez, the following prayer was offered by Guest Chaplain Rabbi Neil Comess-Daniels of Temple Beth Shir Shalom:

In my congregation's prayerbook, I inserted a section from Anne Frank's diary. I precede the reading like this:

The words we are about to read should not be in any prayerbook—but they must be. And yet, these words do not belong to us. We are trespassing when we read them. They were never intended for us. They were from a young girl to herself—an attempt to create a cocoon so that she might feel safe from the insanity around her.

We read these words not merely to remember, but to make a pledge—that we will create a world in which no child, anywhere, will ever feel the need to write words like these again. In the Manzanar Japanese internment camp, a child wrote a diary like this. In Sarajevo, a child wrote a diary like this. In Darfur, a child is *writing* a diary like this. Never again—for anyone.

Anne Frank wrote:

"... I still believe that people are really good at heart. I simply can't build my hopes on a foundation of confusion, misery and death. I see the world gradually being turned into a wilderness. I hear the approaching thunder, I can feel the suffering of millions and yet, if I look up into the heavens, I think that it will all come out right one of these days, that this cruelty will end, and that peace and tranquility will return again. In the meantime, I must hold on to my ideals, for perhaps the day will come when I shall be able to carry them out."

Before and within the Eternal Oneness infused with the potential for mercy, we offer this prayer today, so that we will remember and embrace both Jew and non-Jew who perished in the Nazi Final Solution. We pray today to remember those who continue to die in places gripped by bigotry and xenophobia. We pray today, for and to all the children of war and hate, to become vessels of love, compassion, reason and justice, so that they might live in peace.
