**PRAYER**

Today we pray for the souls and honor the memory of the victims of the Armenian Genocide, the first genocide of the 20th century, premeditated and perpetrated by the Ottoman Turks in 1915.

California State Assembly's recognition of the heinous crime against humanity encourages the Armenian American community of this great state to remain steadfast in the quest for justice. Above all, the noble act grants us spiritual strength to hold firm the essence of our faith as devoted citizens of this blessed country of the United States of America.

In 2015, the Armenian American community and Armenians worldwide commemorated the 100th anniversary of the Armenian Genocide. Very few survivors of the dark genocide remain and they pass on each day. However, their unconquerable spirit will live forever. We honored their memory, thus not only as a form of respect for their martyrdom, but also as a clear message to all nations that the gift of life granted to us by God cannot be taken away forcibly or brutally. The 1.5 million Armenians who perished 101 Aprils ago have been canonized as saints of the Armenian Apostolic Church.

God's divine peace can be secured with faith in the Almighty and respect for human life regardless of religion or ethnicity. We are reminded of the words of the great Reverend Dr. Martin Luther King, Jr., who in his last sermon said, "Like anybody, I would like to live a long life. Longevity has its place. But I'm not concerned about that now. I have seen the promised land. I may not get there with you. But I want you to know tonight, that we, as a people, will get to the Promised Land!"

We are here today with dual responsibilities as Armenians who ought to guard and cherish their God-given gifts, and we are also here as citizens of the United States of America filled with the spirit of the founding fathers of this great nation to become exemplary leaders of our communities.

Almighty God, bless this Assembly with their members and their mission. Grant them divine wisdom and love to carry on their duties diligently, to uphold firm justice for the past and be the path of justice for all generations to come.—AMEN.

#### **RECESS**

By unanimous consent, at 1:39 p.m., Speaker pro Tempore Mullin declared the Assembly recessed to permit the introduction of special guests.

Assembly Member Eggman welcomed international guests in conjunction with the Sikh Parade in Stockton, home of the largest and oldest Sikh Temple in the United States: Dr. Harshinder Kaur, a physician from Punjab, India, and the first female doctor to deliver a speech in Punjabi at the International Conference on Women's Rights in Asia held at the United Nations Campus in Geneva; Sukhpal S. Khaira, from Punjab, India, has advocated for human rights, religious freedom, and clean drinking water; and Harvinder Riar, television host for Jus Punjabi in New York who focuses on quality of life, equal rights, and international issues pertaining to Sikhism through his program, "Matter of the Day."

Assembly Member Kim introduced Bree Morse, Miss California 2015, and commended her work to support the National Alopecia Areata Foundation and the Children's Miracle Network. Assembly Member Holden introduced Dr. Lucile Jones, a seismologist with the United States Geological Survey and a Visiting Research Associate at the California Institute of Technology (Caltech) Seismological Laboratory for more than three decades; a partner with the City of Los Angeles, serving as the Mayor's Science Advisor for Seismic Safety; and Science Advisor for Risk Reduction in the Natural Hazards Mission of the United States Geological Survey (USGS), leading long term science planning for natural hazards research including the creation of Southern California Debris Flow Warning System.
