PRAYER

Upon invitation of Speaker pro Tempore Yee, the following prayer was offered by Rabbi Daniel Pressman, of Congregation Beth David, in Saratoga:

Two weeks ago Jews around the world observed Passover—celebrating liberation from slavery. The Exodus story taught the world that God hates tyrants and sides with the oppressed—a lesson humanity is still learning. Today marks Yom Haskoah, Holocaust Remembrance Day. The Holocaust teaches us many lessons. One is that in 1934, the German people confirmed Hitler as *absolute ruler* of Germany, by a 90% vote. He didn't just seize power—the German people gave it away.

We Americans can be grateful that *our* rights and freedoms are more deeply rooted in law and governance, and that our legislatures are alive with debate and deliberation.

And so we pray that we will always remember that there is no freedom without justice, and no justice without freedom. That American patriotism is founded on the right to differ and dissent. And that truth is best discovered not through declarations handed down by exalted authority, but by the free discourse of equals.

On this Holocaust Remembrance Day, may we take to heart the ancient lesson, to abhor tyranny, and the modern lesson to treasure freedom, and may we remember always what the prophet Jeremiah taught us, that God delights in kindness, the rule of law, and justice.—AMEN.
