PRAYER

Upon invitation of Speaker pro Tempore Yee, the following prayer was offered by Guest Chaplains Archbishop Hovnan Derderian and Archbishop Moushegh Mardirossian:

Oh Lord, Gathered here today in the State Capitol are individuals elected by their peers to serve the people of California. By God's will may they have the strength and fortitude to be good stewards of the land and people that they have been entrusted with.

This legislature is a fellowship of those who are entrusted with the god-given mission to serve humanity, to bring justice to people's lives with a vision of respect for history.

We offer our prayers to the Almighty in remembrance of the victims of the first genocide of the 20th century perpetrated by the Ottoman Empire against the Armenian people. We acknowledge that to this day it remains unpunished, thus giving way to subsequent genocides, among which we all remember with the tragedies of the Holocaust as well as Cambodia, Rwanda, and even today in (the) Sudan.

Service to humanity without rendering respect for the past cannot possibly reflect in its fullest sense the love of God, which begets a true love for humanity. Let this prayer be a special moment for us to remember the Martyrs of the Armenian genocide. I share on behalf of the Armenian Church and the community that today we are celebrating the commitment of our forefathers to maintain their identity—as sons and daughters of the Armenian nation—of their Christian faith. Above all, they have inspired us to become respectful citizens of the United States of America in pursuing justice for the Armenian cause. It was in the great state of California that many of our ancestors found manifold blessings when they sought refuge during a time of great tragedy and strife.

I commend you all for considering the two pieces of legislation regarding the Armenian Genocide put before the legislature today. I especially commend those who in introducing the legislation have stood fast and firm in their commitment to the truth.

Truly, the recognition of the genocide will be the response of our prayer. We cannot be political in our prayers; we cannot be political in our respect for history. The truth cannot be hidden. The truth cannot be compromised. When we look at history, unfettered by subjective preferences, it is indeed virtuous to accept the truth despite consequence of convenience.

It is my final prayer that we should all, through the love and grace of God, find the strength to engage both our history and future with bravery and virtue.—AMEN.
