PRAYER

Upon invitation of Speaker pro Tempore Yee, the following prayer was offered by Guest Chaplain Rabbi Mona Alfi, Executive Director of the Hillel at Davis and Sacramento:

As we memorialize the Holocaust today, I am reminded of Emma Lazarus's poem, the "New Colossus," inscribed at the base of the Statue of Liberty. It teaches us that America's greatness lies in our ability to invest in people, in their dreams and in their hopes for a better tomorrow. Inscribed at the foot of Lady Liberty are these words:

"Not like the brazen giant of Greek fame, with conquering limbs astride from land to land; here at our sea-washed, sunset gates shall stand a mighty woman with a torch, whose flame is the imprisoned lightning, and her name Mother of Exiles. From her beacon-hand glows worldwide welcome; her mild eyes command the air-bridge harbor that twin cities frame. 'Keep ancient lands, your storied pomp!' Prize she with silent lips. Give me your tired, your poor, your huddled masses yearning to breathe free, the wretched refuse of your teeming shore. Send these, the homeless, tempest tossed to me, I lift my lamp beside the golden door!" (*The New Colossus*, by Emma Lazarus)

Today we remember the refugees, the survivors, and the victims of the Shoah, the Holocaust. We can only imagine what those words must have meant to the survivors and refugees who sought to create a new life here. They were indeed the homeless and the tempest tossed yearning for freedom and for safety.

May we on this day of remembering the Holocaust, never forget the importance of extending a hand to those in need. As we remember those who perished, may we remember the words "Never Again." Never again should any of us sit quietly as we watch a genocide occur. Never again, shall we passively watch populations transferred against their will, forced into exile, or worse. May we never again be silent when we see men, women and children seeking refuge for their families.

May it be God's will that in our act of remembering today, that peace and comfort be granted to those who have suffered, and that for those of us who have not known that pain—may our hearts be softened towards those who turn to us for help. May America's light forever shine as a beacon of hope.—AMEN.
