Upon invitation of Assistant Speaker pro Tempore Bauer-Kahan, the following prayer was offered by Assembly Chaplain Rev. Patti Oshita:

Please join me in a moment of reflection.

The Armenian Genocide of 1915. The Jewish Holocaust during World War II. The Cambodian Genocide in the mid-1970s. The Rwandan Genocide of 1994 where 70 percent of the Tutsi population were killed. Sadly, the list of atrocities is not short. Each was a nightmare, so unthinkable, they defy description. Each marks a time in human history when selfish arrogance seized power and governments filled people's hearts with hatred. Each time, human decency was buried by a hateful rage that allowed those in power to justify their calculated campaigns of unimaginable cruelty.

This past Easter Sunday in Sri Lanka, hate-filled arrogance again attempted to prevail as 321 people were killed in coordinated explosions. The perpetrators claim that the bombings were "in retaliation for the attack on Muslims in Christchurch" just last month. But this poor attempt to justify mass murder only reveals how arrogance and hate, too often, try to disguise themselves as a righteous crusade.

We must never forget that we human beings, we are so much better than this. The wisdom of Mahatma Gandhi continues to ring true. "We must not lose faith in humanity. An eye for an eye will leave the whole world blind."

We cannot grow numb to such violence. We cannot allow self-righteous arrogance to blind us from seeing that we are not separate from each other. Although at times we may despair, we must never lose faith in the Goodness of our shared humanity.
