Tribute to Leonard Grimes

I would like to close the Session today in honor of our dear friend Leonard Grimes who passed away last Thursday at his Sacramento home. A native Californian, born in Los Angeles in 1923, Leonard Grimes was a unique individual who balanced a distinguished career in public service with an equally celebrated career as a tireless volunteer who supported numerous important and worthy causes. If you asked Leonard what he was most proud of, I believe that he would say that he was fortunate enough to have the honor of mentoring so many young people in all of his jobs. Leonard was a humble man whose sense of justice and passion for life touched whomever he came in contact with.

Leonard's public service career spanned both Democratic and Republican Administrations, with gubernatorial appointments from each. His last job in the public sector was as Assistant Director Special Projects for the Department of General Services, having been appointed by Governor Deukmejian in 1984.

He began his career in state government in 1975 when Governor Jerry Brown appointed him as Director of the State Department of General Services. Under Leonard's Directorship he oversaw the multi-million dollar State Capitol Restoration where we meet today. He next became the Secretary of State and Consumer Services Agency and a member of the Governor's cabinet.

In 1979 Governor Brown appointed him to the Public Utilities Commission where he was the first Black American to serve in that capacity. He was elected President of the Commission in 1983 and reelected President in 1984.

Leonard's career began in Los Angeles with the Golden State Mutual Life Insurance Company, the largest black-owned life insurance company in the nation, where he served as Vice President and a Board member of the Golden State Minority Foundation which provides scholarships to minority university students.

A veteran of World War II where he served in the Pacific Theater, Leonard received an honorable discharge in 1946.

Leonard was also an accomplished photographer, painter and stained glass artist and a music lover with an extensive and eclectic collection. He shared his passion for the arts with his friends.

Some of the beneficiaries of his community service were the Truman Club, 100 Black Men, the IDEA gallery in Sacramento, and the Busing Program in the early 1960's in Los Angeles.

He leaves behind his wife of many years, Joan Benbrook, and a daughter, Carla.
