**REQUEST FOR UNANIMOUS CONSENT TO PRINT IN JOURNAL**

**Legislative Intent—Assembly Bill No. 12**

Dear Mr. Wilson: The purpose of this letter is to clarify the legislative intent behind two provisions of my bill, AB 12 (Chapter 531, Statutes of 1999) relating to second opinions. AB 12 generally allows a health plan enrollee to obtain a second opinion if specified conditions are met.

One of the key provisions of my bill allows a health plan enrollee to obtain a second opinion outside of their contracting medical group when they were requesting a second opinion from a specialist. One of the major issues revolved around who would pay for the second opinion—the health plan or the enrollee's contracting medical group. When this provision was added to my bill on August 16, 1999 in the Senate Insurance Committee, the committee amendments required the health plan to pay for second opinions outside of the contracting medical group. The health plans opposed this provision saying that it would require the health plan to pay the second opinion provider at the higher

fee-for-service rates. This provision was further amended on August 24, 1999 and requires the plan to incur the cost of the second opinion “or negotiate the fee arrangements of that second opinion.” The legislative intent was to still require the health plan to pay for the second opinion but allow the health plan to negotiate what the fee was. It was not the intent of the legislation to allow the health plan to unilaterally require the contracting medical group to pay for second opinions outside of that medical group.

Another contentious provision of the bill relates to where the treatment was to take place. While the bill allows a health plan enrollee to obtain a second opinion outside of their contracting medical group, this is just a second opinion. The enrollee must obtain any necessary services “pursuant to the specific contract under which the enrollee is entitled to health care services” (Section 1383.15 (j)). Hence if a enrollee’s contract requires the enrollee to obtain services from their contracting medical group they will be required to do so. If the contract allows the enrollee to go outside of the contracting medical group, then the enrollee may receive services outside of the contracting medical group. It is not the intent of this bill to change where an enrollee must obtain services. The provisions of this bill only apply to the provision of a second opinion.

AB 12 is an important part of last year’s health care reform. It is imperative that it be implemented correctly.
