PRAYER

Upon invitation of Speaker Bass, the following prayer was offered by Guest Chaplain, Rabbi Mona Alfi:

Zachor—Remember. The Hebrew Bible commands us to remember. God commanded us to remember the stories of Creation, so that we will treasure the earth and protect it. God commands us to remember that we were slaves in Egypt, so that we will remember what it felt like to be the stranger, the outsider, the oppressed. Throughout Jewish history, we have been commanded “*Zachor!*”—remember.

After the Holocaust, we heard the call again—remember! But this time the call was not just to the Jewish people, but to humanity. We are commanded to remember so that the memories of those who perished, and those who suffered, will be honored. And we are commanded to remember so that the future can be different than the past.

Those who lived through the Holocaust became witnesses for the world about what happens when we fail to see, and to honor, the humanity in each other. They became witnesses to what happens when people say “I was just following orders,” rather than taking personal responsibility for their own choices. They became witnesses to the dangers of a society whose citizens do not speak out when injustices are committed.

Elie Weisel said that “there may be times when we are powerless to prevent injustice, but there must never be a time when we fail to protest.”

One of the lessons of the Holocaust is that we all have the responsibility to speak out when injustices are committed, because we have seen what happens when people do not.

We each have an obligation to look around at the world we live in and reach out to those who are oppressed or discriminated against. We have an obligation to say stop when innocents anywhere in the world are being murdered. Because with remembrance comes the obligation to do more than remember, we must also act with a sense of integrity and responsibility for one another.

We pray to the Holy One of Blessing, the Creator of all humanity, to open our hearts to all people. May we not be so blinded by our differences that we fail to remember that the Divine Image is reflected in all of humanity.

May this be God’s will.—AMEN.

Guest Speaker Introduced

Acting Speaker Ruskin introduced Dr. John Roth, who is the Edward J. Sexton Professor Emeritus of Philosophy and the Founding Director of the Center for the Study of the Holocaust, Genocide, and Human Rights at Claremont McKenna College. Dr. Roth then addressed the assemblage.

Hard Times

We live in hard times. Even with spring's arrival and glimmers of hope, the economy slumps, war rages, and humanitarian crises—including those in Darfur—are relentless. Suffering has our nation and world in its grip. It is not hard to be discouraged, for we live in hard times.

In hard times, what good can it do to remember the Holocaust? Doesn't such remembrance invite more disappointment, when we consider how little the world has learned from that catastrophe, when we realize that the cry "Never again!" echoes unconvincingly as atrocities large and small take place again and again?

Understandable though discouragement may be, disturbing though it is to contemplate the Holocaust when there is so much human need all around us and demanding our attention now, remembrance of Nazi Germany's genocidal attack against the Jewish people and other groups that Hitler and his followers deemed inferior can help us in our hard times. Such remembrance can bolster resolve that discouragement and despair do not have to be, indeed must not be, the last words.

Elie Wiesel—Holocaust survivor, humanitarian and author, recipient of the Nobel Peace Prize—remembers the arrival of American troops at Buchenwald in mid-April 1945. “I will never forget the American soldiers and the horror that could be read in their faces,” he writes. “I will especially remember one black sergeant, a muscled giant, who wept tears of impotent rage and shame, shame for the human species, when he saw us. He spewed curses that on his lips became holy words.” Wiesel adds, “We tried to lift him onto our shoulders to show our gratitude, but we didn’t have the strength. We were too weak even to applaud him.”¹

With help from people like that black American sergeant, but above all from their own determination and inner resources, survivors of the Holocaust found renewed strength. Enduring the hardest of times, they went on, reestablished their lives, gave birth to children, built new homes, learned new languages, brought their professions and skills to new places, adding immensely to the nations and communities where they sometimes had to battle antisemitism and insensitivity that urged them to leave that past behind, which, of course, they could not do, at least not completely.

Holocaust survivors have blessed American life in countless ways, but in our current hard times their greatest gift to our nation and to California in particular, where many found homes, is this: They tell us *do not give up*. In their special ways, they show us that *life is good and it can be better*.

In his 1978 book *A Jew Today*, Elie Wiesel includes an imagined post-Holocaust dialogue between a father and his son. Perhaps the exchange is between himself and his father, who died in Buchenwald. The father asks: “*How are you able to resist despair? How are you able to resist?*” The son replies: “Easy. Whenever something pleasant happens, I close my eyes and see myself thirty years ago; and whatever seems good is not so good, after all. And whenever sadness and disappointment enter my life, I close my eyes and see myself thirty years ago; and what seems terrible is not so terrible, after all.”²

In our hard times, remembrance of the Holocaust can and should help us to see that what seems terrible is not so terrible, after all. Remembrance of the Holocaust can and should help us to resist the forces, including our own discouragement, that would lead us to give in, to give up, by settling for “good” that is not so good, after all, because it is less than we can and should achieve.

Yes, we live in hard times. Remembrance of the Holocaust and all that was lost in that disaster can put our hard times in perspective. Honor rightly paid to the Holocaust’s survivors and to those who helped them to rebuild life in the ruins provides examples that our respect for them and our own self-respect urge us to follow.
