Members of the Assembly: As requested by Chapter 342, Statutes of 1999, the Bureau of State Audits presents its audit report concerning the State Bar of California's (State Bar) disciplinary process, its stewardship of members' fees, and its administrative practices.

This report concludes that, in recovering from its virtual shutdown, the State Bar has reduced costs and improved the effectiveness of its disciplinary process by developing a priority system that allows staff to address the most serious disciplinary cases first. In addition, the State Bar has taken steps to ensure that its dues for members are reasonable and that it uses required dues to support only the State Bar's mandated functions and not the programs in which members participate voluntarily. However, to avoid using an unnecessarily large portion of membership fees to reimburse the complainants in discipline cases and to pay the costs of these cases, the State Bar needs to recover from disciplined attorneys a higher percentage of its disciplinary costs. Moreover, the State Bar needs to maintain credibility with its members and the public by making certain that employees use properly the State Bar's purchasing cards and business expense account, and adhere to its contracting policies and procedures.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the University of California's (university) employment practices for casual employees.

This report concludes that the university offered casual employees more limited retirement and health benefits than it offered career employees, even though some casual employees were employed in the same occupational groups as career employees and may have worked

the same number of hours for a limited time. In addition, the use of casual employees varied among the campuses, ranging from a low of 10 percent of casual employees to total casual and career employees at the University of California, Davis, to a high of 24 percent at the University of California, Los Angeles.

Several factors contributed to the differences in the use of casual employees, including whether a campus centrally monitored casual employment or used outside contractors to perform work that casual employees performed at other campuses. While some departments' decisions to use casual employees for fluctuating or sporadic work seemed appropriate, we found instances where departments' use of casual employees was not always reasonable. For example, some casual employees who worked as research or laboratory assistants at more than 50 percent time for an extended period could have been provided career status and full benefits during that time.

However, recently the university modified its policies regarding casual employment, which should provide casual employees with greater access to career status and the associated benefits. Finally, we found that casual employment had no uniform pattern of impact with respect to ethnic groups or age groups.

Members of the Assembly: As required by Chapter 540, Statutes of 2000, the Bureau of State Audits presents its audit report concerning the progress made by the Department of Health Services' (department) Childhood Lead Poisoning Prevention Program in identifying and protecting children with lead poisoning.

This report concludes that the department has only made limited progress in fulfilling its most critical missions related to lead poisoning and has not fully implemented all of our previous recommendations. Currently, the department does not ensure that all those children it has identified with lead poisoning receive proper medical care and are protected from further exposure. Also, it is still unable to determine the full nature and extent of lead poisoning in California because laboratories are not required to report the results of all childhood blood lead-tests. To its credit, the department has recently established a required standard of care for identifying lead-poisoned children, but lacks a plan to monitor and enforce this standard. Further, the department has been unsuccessful in its efforts to strengthen statewide enforcement authority to reduce or eliminate identified lead hazards. Although it has improved its outreach and education efforts, the department has yet to finalize its state plan for educating health care

providers. Finally, the department needs to address current staffing shortages and projected funding shortfalls to avoid potential cutbacks in program operations that may further hamper its ability to adequately protect California's children from lead poisoning.
