In the late 1990s, social psychologists began documenting a syndrome called “Computer Psychosis.” Young people were becoming more comfortable interacting with screens and the virtual reality of the cyber world than with people physically present. It has been the loving relationships in our lives that have nurtured our ability to care and appreciate.
