PRAYER

Upon invitation of Speaker pro Tempore Yee, the following prayer was offered by Guest Chaplain Rabbi Mona Alfi:

Elie Wiesel, the Nobel Prize winner, author, human rights advocate, and Holocaust survivor, teaches that “It is incumbent upon us to remember the good we have received, and the evil we have suffered.”¹

On Yom HaShoah, Holocaust Memorial Day, Jews commemorate not only the 6 million Jews who were murdered in the Holocaust, the survivors who were left behind to rebuild their lives, and the civilization that was destroyed with them, but we also remember that in the midst of our hell there was *some* good that was received.

Over the last half century, the government of Israel has honored 11,000 people with the title of “Righteous among the Nations.” These 11,000 people risked their lives, and the lives of their own families, to save a Jew, oftentimes it was someone they didn’t even know.

In a blink of an eye a democracy turned into a dictatorship, neighbors into predators and children into informants. And yet, in the midst of this, at least 11,000 people had the courage to say no. No to hatred! No to injustice! No to genocide!

Elie Wiesel also reminds us that “there may be times when we are powerless to prevent injustice, but there must never be a time when we fail to protest (it).”²

May we on this most solemn day of remembrance never forget that regardless of the differences in our religious beliefs, the languages that we speak, or the color of our skin, we are *all* beloved to God, and should treat each other in such a manner.

May the Holy One, the Creator of *all* humanity, never fail to give us the courage to protest the unjust law or a cruel act of hatred. May it be God’s will that in our act of remembering today, that peace and comfort be granted to those who have suffered.—AMEN.
