**SPEAKER PÉREZ DELIVERED KEYNOTE ADDRESS**

Speaker pro Tempore Campos presented the Honorable John A. Pérez, Speaker of the Assembly to the assemblage, whereupon he delivered the keynote address to the Members of the Assembly and Latino Spirit Award Honorees, and without objection, the Speaker's address was printed in the Journal as follows:

Members, today we celebrate the 13th annual Latino Spirit Awards, presented to distinguished members of the Latino Community who have added to the richness and vibrancy of California life. We celebrate their accomplishments in fields as diverse as entertainment to the judiciary.

We have traditionally held this ceremony in close proximity to Cinco de Mayo, and today we are fortunate to present these awards on Cinco de Mayo itself. That lends today's commemoration an added poignancy. As we are well aware, Cinco de Mayo commemorates the victory of Mexican forces over a vastly superior French army during the Battle of Puebla. And while that is certainly a moment of pride for Mexico and people of proud Mexican heritage, we recognize that Cinco de Mayo, much like St. Patrick's Day, is a uniquely American holiday.

Traditionally, this holiday is observed in Puebla, where the battle was fought, without much note in the rest of Mexico. Yet, throughout California, celebrations have been held all weekend, in communities stretching from the Oregon Border to San Diego, and certainly in every other state of the Union.

In all of those celebrations, we celebrate the pride that Mexican-Americans feel towards our heritage. That is unmistakable. But like St. Patrick's Day, or Chinese New Year, we are also celebrating our national heritage as Americans—our long and proud tradition of being a nation that is defined not by geography, not by ethnography, but by a powerful belief in inclusion and opportunity, and equality for every person.

Today's ceremony is not just a celebration of Latino Heritage—it is a celebration of the rich diversity woven into our very national fabric. It is celebration of those three cherished words which define our nation—*e pluribus unum*. These three words speak so powerfully to the American Experience—to the notion that anyone, no matter who they are, or where they come from, can have the same opportunities to succeed in life and make the most of their potential.

That spirit is so vividly displayed by today's honorees. Each of them have made enormous contributions to our state—from iconic work in films, music and athletics, to groundbreaking work in political organizing, elective office, and fighting for justice. Each of today's honorees carry with them the spirit of pride in their Latino heritage, and the spirit of inclusion that makes California such a unique and celebrated place in the world.

Today's celebration reflects the gains we have made as a community, certainly, but they also reflect the spirit of democracy that we all cherish.

This is the 13th time the Legislative Latino Caucus has presented these awards in its 41-year history, and the Caucus itself is an expression of that spirit of inclusion and opportunity.

For 41 years, our caucus has served as a voice for Latinos in government. We are not a monolith. There is a great deal of diversity—of culture, background, history, and worldview. That diversity is our strength, because it serves to remind us of the common bonds we all share as proud Latinos, proud Californians, and proud Americans.



1962 was a seminal year in the history of this Chamber, as Phil Soto and John Moreno became the first Latinos elected to the Legislature in the modern era. They would be followed by a successive and growing number of Latinos, as our state came to embrace the diversity that has defined us from the moment of our admission into the Union. One decade following the election of the first Latinos to this Chamber, five more followed, and formed the Latino Legislative Caucus. That was a powerful moment for our community, and a profound moment for California.

Latinos had served in government before, certainly—Romualdo Pacheco had served as Governor in the 19th century, and from Rita Hayworth to Dolores del Río, Latinos had occupied some of the most prominent positions in California's most iconic industry. But the founding of the Latino Caucus was a symbol that a state so inextricably linked with the Latino Community, a state where generations of Latinos had called home—and most importantly—a state that has, from its founding days, portended the future of the country. The voices of the Latino community would be given expression.

It was the famous Greek philosopher Aristotle who said that “if liberty and equality are to be attained in democracy, they are best achieved when all alike participate in government to the utmost.” Not just democracy in the political sense—but democracy in all of the institutions which shape our society. We see that spirit so clearly in our honorees, and in every community across California.

In the 41 years since five Assembly Members came together to form our caucus, we have grown and thrived—from the election of the first Latina in 1982, to the election of the first openly gay Latino in 2008, our caucus continues to reflect the great diversity of California life. We have seen our ranks swell to 86 members over the course of those 41 years, with 24 members serving under this dome today.

California is stronger, more prosperous, more united, and far richer in spirit because of the celebration of inclusion and diversity that today's ceremony represents. The Latino Caucus and our sister caucuses have institutionalized a voice for everyone in government, and ensured that our government reflects the hopes and aspirations of every person in our state. That ultimately strengthens all of us, and that is a powerful legacy of the work of so many trailblazers from our history. That is a powerful symbol of the spirit of inclusion and acceptance that the Latino Caucus represents, and reflects on the broader spirit of inclusion and diversity that forms the foundation of the *California Dream*. We see that spirit in the faces of the members of the caucus. We see that spirit in the ranks of our honorees, and we see that spirit throughout the year as we celebrate those moments of pride—and yes, of sorrow—from so many different cultures, whether it's Cinco de Mayo, our commemorations of the Holocaust and Armenian Genocide, Black History Month, or Chinese New Year. Those celebrations, like our commemoration of the Latino Spirit Awards, are ultimately celebrations of California, because in observing each of them, we do not observe our differences, but rather our commonalities. These are the ties that bind us together as Californians.

Today, we celebrate a moment from the history of Mexico. We celebrate the pride of Latino Californians. But ultimately, today is a celebration of that simple and powerful concept: *e pluribus unum*.

**CLOSING REMARKS**
