Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the Victim Compensation Program (program). This report concludes that program compensation payments sustained a 50 percent decrease from fiscal years 2001–02 through 2004–05 as a result of the Victim Compensation and Government Claims Board (board)

members' attempts to maintain the fiscal viability of the Restitution Fund. Compensation payments have increased since fiscal year 2004–05, but not to the level they reached in fiscal year 2001–02. Despite the significant decline in payments, the costs the board incurs to support the program have increased. These costs—ranging from 26 percent to 42 percent annually—account for a significant portion of Restitution Fund disbursements. In addition, although the board generally complied with state laws and regulations for determining whether applicants are eligible for program benefits, it did not always process applications and bills as promptly or efficiently as it could have. The board's procedures for following up with outside entities to obtain necessary information to verify applications and bills are not sufficiently detailed and contribute to inconsistencies in staff efforts to obtain the information promptly.

In late June 2006 the board began transitioning to its current application and bill processing system. Although the board expects to gain efficiencies and benefits from the use of the new system, it generally has not developed benchmarks or measured results. Further, the board has experienced numerous problems with the transition. Most troubling was our identification of payments that appeared to be erroneous. Although board staff provided explanations, asserting that the payments were appropriate and the data were flawed, the fact that they were unaware of these items indicates the absence of controls that would prevent erroneous payments from being made. In addition, the board's current process for managing its workload is informal: it has not established benchmarks, performance measures, or formal written procedures for workload management. Finally, the board has not established a comprehensive outreach plan to assist it in appropriately prioritizing its efforts and focusing on those in need of program services.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the administration of, and processes used for, hearings held by the Office of Administrative Hearings (Administrative Hearings) and the California Department of Education's (Education) role within the process. Specifically, the report addresses how Administrative Hearings has conducted its operations since taking over the special education hearing process from the University of the Pacific's McGeorge School of Law (McGeorge) during fiscal year 2005–06.

This report concludes that when we compared the costs incurred by McGeorge to conduct hearings and mediations to the costs incurred by Administrative Hearings, we found that the average cost per case closed had increased by 14 percent since Administrative Hearings began managing the hearings and mediations process. We also found that the average time McGeorge took to close cases was 185 days, whereas, Administrative Hearings took an average of 118 days. Moreover, the number of cases closed before administrative law judges issued a hearing decision has not changed significantly since the years when McGeorge administered the hearings and mediations. We also found that when reviewing the outcomes of hearing decisions issued by McGeorge and Administrative Hearings over the last six years, McGeorge's data show that during the earlier two years it issued decisions in favor of students more often than did Administrative Hearings. However, by fiscal year 2004-05 McGeorge's decisions favoring students had decreased to a level that more closely matches the data for all three years that Administrative Hearings has overseen the process. Further, for the six years covered in our review, we could not determine the total number and costs of hearing decisions that students or school districts appealed to higher courts because neither Education nor any other entity consistently or completely tracks this information nor do laws require them to do so.

Our review also found that Education has established standards that Administrative Hearings must follow when administering the special education hearings and mediations process. We observed that, in general, Education appropriately oversees Administrative Hearings' execution of its interagency agreement with Education; however, it could tighten its oversight of Administrative Hearings in a couple of areas. Specifically, our review of one of Administrative Hearing's quarterly reports for each fiscal year between 2005-06 and 2007-08 found that it had not consistently included in these reports 10 items that the interagency agreement requires. Additionally, Education has not taken the steps to verify that Administrative Hearings ensures its administrative judges receive the training required by state law and the interagency agreement. Finally, our audit also revealed that Administrative Hearings has not always issued hearing decisions within the legally required time frame, which could potentially lead to sanctions by the federal government and affect special education funding for the State.

Dear Governor and Legislative Leaders: This letter report presents a summary of the results of the Bureau of State Audits' assessments of the reliability of data for the purposes of its audits in a wide variety of databases and automated spreadsheets. Data reliability refers to the accuracy and completeness of the data, given our intended purposes for their use. The State uses these data in many ways, which include reporting on its programs, tracking licensees and recipients of funds, disbursing funds, and making program decisions. Although we have disclosed these data reliability assessments in 24 audit reports we issued during 2006 and 2007, this report is intended to call attention both to areas of concern, where important data are not always reliable, as well as to instances when information has been reliable. We have conducted our assessments in accordance with the provisions of the federal Government Accountability Office's Assessing the Reliability of Computer-Processed Data, which require us to assess and report on the reliability of the data from automated systems we use to reach our audit conclusions. We anticipate that this report will be the first in a series of reports on the subject.

Many systems had reliable data for our purposes, but some important systems did not. During the 24 audits, we assessed the reliability of specific data for 68 different purposes in 46 separate database and spreadsheet systems. For 30 audit purposes, we concluded the data were reliable, so that using the data would not weaken our analysis or lead us to an incorrect or unintentional message. We found, for example, that the Board of Equalization had reliable data allowing us to determine the level of additional revenues generated in fiscal year 2004–05 by new cigarette and tobacco licensing legislation.

However, for 19 purposes, we reported the data were not sufficiently reliable, meaning that using the data would most likely lead to an incorrect or unintentional message and that data have significant or potentially significant limitations, given the audit topic and intended use of the data. For instance, a Department of Education database had some obviously unreliable information about staffing levels at local school districts, in which certain individuals were credited with more than 1.5 full-time equivalent positions. As a result, we had to adjust the data to provide more reasonable information.

For the remaining 19 purposes, we were unable to determine the reliability of the data; therefore, we concluded that use of the data could lead to an incorrect or unintentional message and the data have significant or potentially significant limitations, given the research question and intended use of the data. In some cases, our conclusion that data were of undetermined reliability arose from issues that were either beyond the control of the audited agencies or were not a cause for concern. The undetermined reliability conclusion for cost-effectiveness data on proposed projects at the State Air Resources Board was not a

cause for concern, for instance, because it arose from an acceptable business practice—the information was entered directly into the database. Nevertheless, without hard-copy documentation, we were not able to assess the accuracy of the cost-effectiveness data. At other times, however, we were not able to determine data reliability because the data had errors or omissions and we could not quantify the extent of the problems. Two compensation databases at the University of California and California State University, for example, suffered from inconsistent input or lack of supporting documentation from the various campuses providing data. As a result, we were not able to use the databases to provide complete and accurate university-wide compensation of highly paid individuals by type and funding source.

In our review of reimbursements to skilled nursing facilities for Medi-Cal services they provided, we discovered that the State's fiscal intermediary responsible for calculating and preparing remittance advices for those reimbursements authorized duplicate payments. In subsequent work, we reported that the system flaw resulting in the duplicate payments also existed for payments to other types of providers. After we discovered these duplicate payments and pointed out the magnitude of the system flaw, the Department of Health Care Services<sup>1</sup>, which administers the Medi-Cal program, performed further analysis and identified \$5.1 million in overpayments to 532 skilled nursing facilities, much of which it asserted it had recovered as of January 31, 2008. However, we could not validate this information because it did not retain the supporting documentation for its claims.

The Table on pages 10 through 13 summarizes selected information from the pages referenced in the Appendix. The data reliability assessment relates to the purpose we tested the system's data for during the audit as described in the Appendix. The agency's use of the system's data usually, but not always, is similar to our use of the system's data.

Members of the Assembly: Pursuant to the California Whistleblower Protection Act, the Bureau of State Audits presents its investigative report concerning acquisitions of information technology (IT) goods and services by California Prison Health Care Services (Prison Health Services) with the assistance of the Department of Corrections and

Rehabilitation (Corrections). When Prison Health Services discovered that some of its IT acquisitions had been made with a single vendor in 2007 and 2008 without complying with either the state contracting process or the alternative contracting processes established by a federal court, they requested that we investigate the matter.

This report concludes that staff at Prison Health Services ignored state contracting laws, as well as the alternative contracting requirements established by a federal court, when it acquired \$26.7 million in IT goods and services in a noncompetitive manner from November 2007 through April 2008. Specifically, Prison Health Services used 49 purchase orders to acquire \$23.8 million worth of IT goods from a single vendor when it should have sought competitive bids. It also contracted with the same vendor to provide \$2.9 million in IT services again without using a competitive process. Further, staff at Corrections helped to execute the purchase orders for Prison Health Services after initially questioning the propriety of the process used. Consequently, the State cannot be certain that Prison Health Services spent \$26.7 million in public funds prudently or that it received the best value for the money spent.

Members of the Assembly: As authorized by Chapter 251, Statutes of 2004, the Bureau of State Audits (bureau) presents its report concerning its addition of the State's budget condition to its list of high-risk issues. In May 2007 the bureau published its initial assessment of the high-risk issues the State and select state agencies face. Our initial assessment identified five significant statewide risk areas and two specific state agencies facing challenges to their day-to-day and long-term operations. Based on the current fiscal crisis and a history of ongoing deficits, the bureau has added the State's budget condition to its list of high-risk issues. We believe that the record-breaking delays in passing the fiscal year 2008–09 budget, the need for subsequent special sessions focused on the budget, and the multibillion dollar budget gap lawmakers are attempting to close highlight the potential for the State's budget process and condition to add significant roadblocks to the tasks of managing and improving state and local government.

In analyzing information on budget deficits and surpluses during the last 20 years, using various methods of determining the budget condition, we found that all measures pointed to the same conclusion—the State has experienced ongoing deficits that greatly outweigh any surpluses. Although these results indicate that the State has faced a long-standing problem, we found that nearly half of the amounts related to the budget solutions implemented to resolve the shortfalls have only pushed the problem into the future. This report also identifies various factors that make it difficult for decision makers to reverse this course. Because we have designated the State's budget condition as high risk, the bureau will continue to monitor developments in this area, clarify issues when needed, and attempt to help decision makers find areas to streamline government or enhance revenues.
