Legislative Intent—Assembly Bill No. 1087

Dear Mr. Speaker,

This letter is being sent for publication in the journal. The purpose of this letter is to clarify the intent of Assembly Bill 1087, relating to the certification of electricians.

It is not the author's intent under AB 1087 for electrical education and training gained through apprenticeship programs approved by the federal Bureau of Apprenticeship and Training could not be used to meet the requirements for certification under Labor Code Section 3099.

The language contained in Labor Code Section 3099.2 (d) in the April 30, 2002 amended version of AB 1087, makes clear that apprentices participating in federally approved programs may work as electricians without first obtaining certification and that these apprentices may take the certification examination when they are within one year of graduation and, upon passing the examination and completing the apprenticeship programs, be certified.

Section 3099.2 (d) reads:

"Notwithstanding subdivision (a), certification is not required for registered apprentices performing electrical work as part of an apprenticeship program approved under this chapter, a federal Bureau of Apprenticeship Training program, or a state apprenticeship program authorized by the federal Bureau of Apprenticeship Training. An apprentice who is within one year of completion of his or her term of apprenticeship shall be permitted to take the certification examination and, upon passing the examination, shall be certified immediately upon completion of the term of apprenticeship." [Emphases supplied.]

Indeed, AB 1087 treats apprentices in federally approved programs identically apprentices apprenticeship to California-approved apprenticeship programs. There discrimination whatsoever against apprentices in federally approved programs.

Another provision added by AB 1087 (Labor Code Section 3099.4) also provides that any person may work as an uncertified electrician without enrolling in an apprenticeship program if the person has completed or is enrolled in an approved curriculum of classroom instruction. Once the approved curriculum of instruction is completed, moreover, the person may take the certification examination.

In short, the intent of AB 1087 is to provide a wide variety of avenues by which individuals may acquire the classroom instruction and on-the-job experience leading to certification as competent journeyman electricians.

I hope this will dispel any of the confusion that may have arisen when this measure was heard in Assembly Labor and Employment Committee on May 9, 2002.
