REQUEST FOR UNANIMOUS CONSENT TO PRINT IN JOURNAL

Upon request of Assembly Member Shelley, Assembly Member Papan was granted unanimous consent that the following communication be printed in the Journal:

William R. Burke Biography

William R. Burke, Past National Commander of the American Legion and public relations consul, died peacefully on May 6, 2001 after receiving Communion at a family Mass in his California Palos Verdes Estates home.

A graduate of St. Elizabeth's Catholic parochial school in Altadena, he spent two years at St. Joseph's Junior Seminary in Los Altos Hills before graduating from Cathedral High School in Los Angeles. He received a B.A. in history in 1939 from UCLA, working his way through school as a baritone soloist with bands and orchestras.

In 1941, to further interfaith harmony in the United States, he joined a "trialogue" team with George Hill, a young Baptist minister and Gilbert Harrison, future editor of the *New Republic*. They toured high schools, and over 40 universities and legislatures throughout the United States introducing themselves as a "Catholic," a "Protestant," and a "Jew". The ecumenical team was sponsored by the National Conference of Christians and Jews and the Religious Conference at UCLA.

In 1943, Bill married Jeane Barnbrock, a California raised New York native, whom he met in a public speaking course at UCLA. They had five children, Brandon, Christopher (deceased), Sharon, Susan and Thomas and raised their family in Palos Verdes Estates, California.

Bill served as an officer on the U.S.S. Pillsbury, a destroyer escort that was part of the task force which captured the U-505, a German submarine. Hospitalized as a result of a depth charge concussion, Bill concluded his Navy career teaching Naval Law at Princeton and Notre Dame Universities.

With the support of the Association of Motion Picture Producers and individuals such as Bob Hope, Walt Disney, Loretta Young, Lena Horne, Melvyn Douglas, Vincent Price, Jimmy Stewart, and religious leaders of Protestant, Catholic and Jewish faiths, he and the Executive Director of the University Religious Conference, Adeline Guenther, organized the first exhibit in the United States of Mexican Art and Culture and later the first exhibit of African-American Art and Culture. Works of art were loaned from all over the United States. Underprivileged children and gang leaders from metropolitan Los Angeles were brought in to view the exhibits. It was a thrill for board members and staff of the University Religious Conference to see the troubled youngsters' positive reactions to works of their native culture.

He founded William R. Burke Public Relations, Inc. in 1945, a legislative advocacy firm with offices in Washington, Sacramento, and Los Angeles, which specialized in humanitarian issues. His firm obtained tax exemptions for all religious school properties throughout California, after 69 years of unsuccessful efforts by others. Also, among his first efforts was the repeal of the Oriental Exclusion Act, which made it possible for "legally resident aliens" to become United States citizens. His work on behalf of Displaced Persons of Europe after World War II resulted in thousands of families and individuals being relocated in communities in the United States where they were welcomed because dwindling populations had left severe labor shortages.

In 1946, with Ronald Reagan and Gilbert Harrison he formed the American Veterans Committee. However, the three friends, each then a Democrat, eventually decided their efforts to serve World War II veterans, their families and their country would better be served by the already well-established programs of the American Legion. He joined Post 8, the second oldest post in the State. In 1953, he was elected Department Commander of the State of California.

In 1960, Bill's National Commander campaign trail throughout the United States frequently crossed those of Richard Nixon and John Kennedy. Before his election to National Commander in October 1960, he moved his family to Bermuda to wait out a term of office which involved visitations to 50 states and 11 foreign countries. Upon his return from visiting S.H.A.P.E. and NATO operations, Pope John XXIII and from visiting heads of state in Mexico, Israel, Taiwan, China, Japan, Korea, Germany, France, Italy, England and Ireland, all but three members of Congress attended a dinner at which he reported his observations.

In January of 1961, he addressed the California State Legislature, the first and last time a lobbyist has been invited to speak from the House rostrum to a joint session. Affectionately called "The Cardinal" by lobbyists and legislators alike, he was a popular speaker who drove home his concerns about serious problems with Irish wit and humor.

Bill worked closely with civic, religious, educational, industrial, labor, and veterans' groups in carrying out programs in areas of importance to the public interest, and has been described as "a man of great understanding, of deep, personal dedication to the cause he serves, and of tremendous qualities of leadership."
