The Sam Levy Department Store was the most prestigious in the city. After her father passed away in the mid sixties, Ella ran the business, eventually having the department store evolve into

a very stylish boutique. Until recently, Ella devoted six days a week to the family's retailing business. Finally, after providing family retailing service to the Torrance populous for seventy-nine years, Ella closed the store a year ago so she could spend more time with her grandson.

A gentle and strong minded woman, Ella was once barred from entering a restaurant for wearing slacks. She was just ahead of her times. With her passing an era of California society disappears.
