# In Memoriam Frank Sinatra

The world has lost one of its brightest stars. I write today to express my sincere sympathy to the family of Frank Albert Sinatra, an unsurpassed artist whose heart and acts of charity grew as wide and boundless as his wonderful voice. When Frank Sinatra died last week, he passed into eternity with our heartfelt esteem and a world of lifelong devotees.

This was a man blessed with enormous amounts of sheer talent. An accomplished dancer, actor, artist, as well as legendary singer, he 'filled our hearts with song' for more than fifty years, and was known the world over as "an entertainer of substance." When he came on the scene in the early 1940s amid a world at war, Frank Sinatra's class and beautiful music gave a richness and style to his age, defining a generation's values while delighting all who would listen.

But along with this talent, Frank Sinatra possessed a charisma and presence that was born to hold the spotlight. When the 1950s began and his star briefly faded, he came back with his life's greatest performances, where his skill and aesthetic depth brightly shined through. In classics like *Oceans 11* and *From Here to Eternity*, we saw a maturing talent, showing the struggles of his life through the passion of his art. Generations would grow with him, from the crazed "Bobby Sox" fans of '42, into refined adults who appreciated the subtle intensity and emotion of his film, dance and music.

No matter how famous he became though, Frank Sinatra would never lose his sense of charity, and willingness to help others in need. The son of Italian immigrants, Sinatra grew up in a working class New Jersey neighborhood where for many, he still embodies the American dream. These roots and a giving heart no doubt produced the great philanthropist he was in private, away from the glow of celebrity.

In our desert community where he drifted in and out of 'unofficial retirement,' Frank and his wife Barbara built the not-for-profit Barbara Sinatra Children's Center for abused children. Founded in Rancho Mirage in 1986 to counsel and treat abused children, the Sinatras' ongoing work provides comprehensive programs to combat the problems of child abuse. By combining and complementing the efforts of police, child protective services, district attorneys and the court system, the Barbara Sinatra Children's Center has assembled the resources for the gentle, measured healing of abused children.

We remember Frank Sinatra by the caress of his elegant music and his many acts of charity. And we all owe him our deepest thanks and to his family, our heartfelt support and sympathy. We have more than just the cultural legacy to help us remember the giving heart of this man. A rare talent who has passed on to the heavens his music sang about, and left behind for us the voice to every love story.
