**REQUEST FOR UNANIMOUS CONSENT TO PRINT IN JOURNAL**

Assembly Member Correa was granted unanimous consent that the following statement be printed in the Journal:

*Hector G. Godinez*

Hector G. Godinez, (retired) District Manager of the United States Postal Service, born July 1st, 1924, on the mission grounds of the San Diego Mission. His family moved to Santa Ana, California about one year later. From that point on, Mr. Godinez made Santa Ana, California his home. He passed away on Sunday, May 16th, 1999 at 12 noon in St. Joseph's Hospital in Orange due to complications from Parkinson's Disease.

He attended Santa Ana schools as a young boy growing up in Santa Ana. From Santa Ana High School, Mr. Godinez entered the armed services and participated in the invasion of France and the ensuing five battles that led to victory in Europe. Mr. Godinez was most proud of his military service to his country in W.W.II as a tank commander for General George Patton's "Black Panthers Seek and Destroy" tank division. Mr. Godinez earned the bronze star for bravery under fire and was also awarded a purple heart for wounds received in battle.

On returning home from the war in 1946, he started his Post Office career as a letter carrier. At the same time he attended Santa Ana College at night from 1953 to 1958, majoring in business administration. He worked for the United States Postal Service for 48 years rising from letter carrier to Southern California District Manager. He was first appointed Postmaster of Santa Ana, California, in 1960, by the then President of the United States, John F. Kennedy. His appointment as Postmaster is recorded in the United States National Archives. During his tenure, Mr. Godinez was bestowed numerous national awards in production, innovation and efficiency for his management of postal operations.

In those early years after the war, Mr. Godinez became a founding member of the Santa Ana LULAC Council (the Santa Ana Council is still active today). Mr. Godinez and those first Santa Ana LULAC members were participants and supporters in bringing to justice the 1948 *Mendez v. The Board of Education* case, a landmark civil rights

case which ended discriminatory practices against Mexican American children in Orange County schools. The Mendez case was later as a friend of the court brief in support of *Brown v. The Board of Education*, argued before the Supreme Court of the United States by Thurgood Marshall.

Through his aggressive style and service to his fellow man, Mr. Godinez became a recognized civil rights leader, Community Activist and nationally honored United States Postal Service executive. He was also National President of the League of United Latin American Citizens (LULAC) 1960–1961, one of the country's oldest and most respected Hispanic civil rights organizations.
