Dear Mr. Wilson: Pursuant to Penal Code Section 7433, the California Department of Corrections is required to provide to the Legislature by January 10, a plan for proposed expenditures from the 1990 (general obligation) Prison Construction Fund.

The last appropriation to the California Department of Corrections from this fund was in 1996 and the fund was essentially depleted at that time. The 1998–99 Budget Act appropriates a small amount of reverting funds in the Department of General Services' budget for the purpose of bringing underground fuel storage tanks at various correctional institutions into compliance with the California Underground Storage Tank Regulations. We do not expect any future appropriations of 1990 funds.

Since the 1990 bond funds are now depleted, the Department will no longer be submitting a plan by January 10, pursuant to Penal Code Section 7433. However, by policy, we will be submitting a Five-Year Facilities Master Plan describing our proposed Prison Construction Program for discussion during the Budget process. The Department is now finalizing the 1999–2004 Five-Year Facilities Master Plan. We anticipate release of this document in April 1999.
