When we transcend the lines and barriers between self and others, feelings of contentment will naturally emerge; as we feel deeply our shared Humanity.

The Persian Spiritual Poet Rumi and this Zen Master would say, "Beyond Right and Wrong, Beyond Inside and Outside, there is a place of Oneness of All Humanity. We will meet you there."
