PRAYER

Upon invitation of Speaker pro Tempore Lowenthal, the following prayer was offered by Reverend Bob Oshita:

In 1945, Albert Einstein and Robert Oppenheimer, helped create the Bulletin of Atomic Scientists. The concerns of these scientists gave birth to the Doomsday Clock. Using the image of the apocalypse being midnight, the Doomsday Clock conveys how close we are to nuclear annihilation.

This year, the Bulletin of Atomic Scientists set the clock the closest to midnight that it has ever been. Considering international relations, global conflicts, climate change, disease, and pandemic potential, the Bulletin of Atomic Scientists has assessed that the world is 89 seconds from Doomsday.

In the announcement, the Bulletin stated, “Blindly continuing on the current path is a form of madness. The United States, China, and Russia have the collective power to destroy civilization. These three countries have the prime responsibility to pull the world back from the brink.”

I grew up having to practice atomic bomb drills in elementary school. The siren would signal us to move into the hallways, away from windows, covering our heads, sitting huddled together where the walls were the thickest. People were naïve and imagined surviving.

We know that in the event of a nuclear war, there will be no winners. It is meaningless for countries to threaten each other with mutual destruction.

The late Archbishop Desmond Tutu described his spirituality with the Zulu word, Ubuntu, which means: I am human because I belong to the whole, to the community, to the nation . . . to the earth.

With our Wisdom Eyes open, we know that all of humanity lives sharing this one and only earth; we must nurture and care for it—and for each other.

Namo Amida Butsu—Let us live with kindness and gratitude beyond words.
