#### **REMARKS IN MEMORIAM**

#### OF

#### PRESIDENT RONALD W. REAGAN 1911–2004

Speaker Nunez was joined by the Members of the Assembly in adjourning this day's session out of respect to the memory of President Ronald W. Reagan, the 40th President of the United States from 1981–1989, and former Governor of California from 1967–1975.

The following remarks were offered as a collective expression of tribute to President Reagan and as an expression of condolence to the Reagan family:

#### by Speaker Fabian Nunez

Members, several of you approached us yesterday and asked that under Motions and Resolutions we adjourn in memory of the 40th President of the United States of America, President Ronald Reagan. A man who left an imprint not only in this State, but in this nation. A man who understood the value of kindness, understood how to reach out to folks, and bring people together. A man who, through the voices and cries of many throughout this nation has been able to set a new tone and tenor of how presidents in this country are judged. Whether you're a Democrat or Republican, Ronald Reagan was our President, Ronald Reagan was our Governor. And so, we honor his memory today as Americans. We honor the work that he did while Governor of the State of California and as President. We honor his life and legacy here today. Without any further ado, let me mention to you that at 3:30 today, Governor Arnold Schwarzenegger has invited all of us to join him in the Rotunda for a signing of a memorial to foster and demonstrate the goodwill of this Legislature to work together and to show our respect for the family of President Ronald Reagan. So, I ask committees to break at 3:15 so we can join the Governor at 3:30 in the Rotunda. With that, it is appropriate at this time to call upon one of our colleagues, Mr. Strickland, in whose district the Ronald Reagan Library is located.

#### by Assembly Member Tony Strickland

On behalf of 34 million people across the State of California it is my honor to adjourn in the memory of President Ronald Wilson Reagan. Not only is the Reagan Library in my district, but I'm lucky enough to live right off the Reagan Freeway. I have two heroes in my life, one is my father, and the other is President Ronald Reagan. Ronald Reagan meant a lot to me and countless other young people who got involved in politics. My story is not uncommon—I was in fourth grade at Simi Elementary School and I got to watch the Reagan Inaugural Address and I went to my parents after that address and I said, "I want to be politically active." Now, my mom and dad thought I was crazy but they always were supportive of their young son, so they got me involved and dropped me off at the headquarters of a local candidate running in the area. But, it was Ronald Reagan's inspiration and the inspiration to

many, many other "Reaganites" as we call them, who were part of the Reagan revolution. And, in Junior High I was asked by a local reporter, "If I could give President Reagan a gift, what would that gift be?" Being 13 years old, and in Junior High, I said "An American Flag, because Ronald Reagan is a true patriot." It's not just Ronald Reagan the man. Everyone talks about how wonderful he was at going across the party lines and how he was the great communicator but Ronald Reagan stood for something. He had ideas, and he had principles that there was no compromise on. And, as a young child I grew up in the Cold War and every day I was scared of nuclear war breaking out. I'd like to quote, if I can, Prime Minister Margaret Thatcher's quote about President Reagan: "Ronald Reagan had a higher claim than any other leader to have won the Cold War for liberty, and he did it without a single shot being fired." I don't think that I could say it any better than the former Prime Minister of Great Britain, that it was Reagan's leadership that allowed young people, my children and my grandchildren, to not have that same fear that I had as a young child. Now, he also started a revolution. A lot of people on this Floor asked me about why it is that I always fight against tax increases and I always want tax cuts. Well, that was called "Reaganomics" and under "Reaganomics" he went forward and cut taxes and he spurred the longest peacetime expansion in this nation's history during those cutting of taxes when he was President of the United States. He cut inflation by one-half and, I noticed people didn't really call it "Reaganomics" anymore after he did a good job of stimulating the economy. Ronald Reagan's wit, his humor, and everything about Ronald Reagan is something that, when I have a child, hopefully a son or a daughter, look make sure that they at the character of President Ronald Reagan, and it's people like my father and President Reagan that I want my children to grow up to be just like them. So, on behalf of the people of California, on behalf of the Reagan Library in my District, and the Reagan Freeway, it's an honor for me to adjourn in the memory of a hero of mine and the hero of many other Californians that got involved in politics because of his inspiration, and because of his leadership. Thank you.

#### by Assembly Member Mervyn M. Dymally

One is influenced by one's experiences and my experience with Governor Reagan was a very pleasant one. I did not have very much contact with him in Washington, but for the eight years he served the people of California, I was a Member of the Senate and I remember him for his accessibility, his availability; and he gave us some very significant pieces of legislation. As for me, every day I drive to work I see his legacy in the form of the Drew Medical School; he gave that to the people of Watts and Willowbrook. He signed the first therapeutic abortion bill in the United States, authored by Senator Beilenson; gave a COLA to welfare recipients; a school lunch program authored by Senator George Moscone; gave Willie Brown large sums of money for the Langley Hospital in his district; equal property rights for women (and this was made possible by his daughter Maureen Reagan); child

growth and development; child abuse prevention; Bilingual Services Act; Child Care Construction Act; and, although he did not have to sign these next two pieces of legislation, the 18-Year-Old Vote and the ERA was passed under his Administration in California; Medi-Cal Reform with Dr. Earl Brian; a tax increase, when it was necessary. He rose above politics and I recall, very vividly, I was involved in negotiations and the majority of Senators in the Democratic Caucus were opposed to a tax increase and we released Senator Roberti at the request of the United Teachers of Los Angeles, to vote for that measure and he did in fact vote to implement a tax increase when it was necessary. But my most memorable moment of Governor Reagan is this one: He campaigned against fair housing in 1966 and when he came here, his Deputy Chief of Staff, Bob Keyes, an African American, former Vice President of Lockheed Burbank, was denied housing in Sacramento and when the Governor heard about this denial, he changed his position against fair housing and came out instead for fair housing and the whole of California changed as a result of it. People can live wherever they can buy now. And that was my fond memory of Governor Reagan. I share the sentiments of Members and all Californians in expressing our deep sympathy to his wife and family. May he rest in peace.

### Minority Leader Kevin McCarthy

Members, I join today to honor, truly, a hero. An ordinary man who did truly extraordinary things. Not just for our state, not just for our nation, but for the world. You know, I grew up in a family of all Democrats and I happened to be the youngest in my family and I came to my party based upon Abraham Lincoln and Ronald Reagan. He was the first President I could vote for and the reason I went down at 18 to register—I saw what he stood for. In the 80's when he became President, if you remember back, America was held hostage for an entire year. Americans didn't believe they could still be the super power. Didn't believe that economically we could as well. And he did it in a unique manner. You know, in my party we have what we call the eleventh commandment the Reagan commandment. You don't speak ill of a fellow member. And when he served they had a speaker, Tip O'Neill. He said, "We may have a difference of opinion during the day, but at 6 o'clock we all become friends again." And that's the way he carried it out—his character. He based it upon the power of the idea. Saturday night, this past Saturday night, I had the honor of sitting down for dinner with Judge Clark. Judge Clark happened to be his Chief of Staff when he was Governor. He happened to be his advisor when he was President. And as I sat there and talked to Judge Clark I was speaking to his wife and I was talking about the former President and I asked her what was her greatest moment with this President? And she said, "You know, I immigrated from the Eastern Bloc. When I stood with him on that wall and he told Gorbachev 'Tear down this wall', that was moving because that's how I came through." And when you think of what the accomplishments are, this weekend was not an ordinary weekend. It was the 60th Anniversary of D-Day. That was the liberating of Europe. I would argue that Ronald Reagan finished the job of liberating Eastern Europe with the power of the idea, the concept of freedom, of liberty, and moving it forward. You know, I'd like to finish with a quote by Ronald Reagan in a speech in 1992. He said, "Whatever else history may say about me when I am gone, I hope it will record that I appealed to your best hopes, not your worst fears; to your confidence, rather than your doubts." I believe he accomplished that—I believe history will be very kind to all that Ronald Reagan has done. Thank you.

I want to say that it's really popular today to say that you're a passionate conservative. I don't think that it started with our generation—it actually started with Reagan. And, as an example of that, ten years ago, when he was first diagnosed with the disease, we didn't hear about it from the press, we heard it from him directly. In his own hand he wrote a letter explaining the disease and how it was going to rob him of his health and he really did not want to forget all of the imprint he had put on us as Americans, and really our job of moving us forward. As the 40th President of the United States, not only did he serve eight years as President, but had served eight years as Governor here in California. And you know, we had just come from the worst of times and we were headed to the best of times. The Vietnam War and its impact had really impacted this country; Watergate had also impacted us, and during his presidency I remember I was in New York at the time, my daughter was five months old and we watched as that rocket ship blew up with our astronauts during his presidency. I was really not involved politically, but I understood the impact that he had, not just for us as Americans but also for people around the world. It was during his presidency, that amnesty meant so much to millions of Latinos here in the United States. For the first time, they had an opportunity to bring themselves out of the shadows and to become real Americans, and in fact, to bring their families legally here to this country, and to give them all of the opportunities that this great country provides for all of us that have the privilege, the absolute privilege of being an American. And, for those people, in Europe, I guess the defining moment for them was when President Reagan actually challenged Gorbachev during that time, and I wrote down what he had to say. The date was actually June 12, 1987, when he stood at the Brandenburg Gate in Berlin and he challenged Gorbachev to dismantle the Berlin Wall. He said "Mr. Gorbachev, open this gate. Mr. Gorbachev, tear down this wall." And we all know what happened afterwards, the wall did come down; a divided country again became one. And it had not just torn down a wall that visually divided a country, but actually let in democratic principles and the free market economy that we have here today and we're able to enjoy. So, today, as we are closing in his honor, I just want all of us as Americans, all of us as human beings on this earth to remember contributions that this man made, sacrifices that his family made, in allowing him to serve us in every capacity that he did and reminding each of us that in some small way we can make a difference because it is leaders like him that have blazed that trail for us.

I rise to adjourn in the memory of President Reagan. He was an inspiration. I never met him but felt that he knew me. He touched all of our lives and made this world a better place to live. I want to relay a story that many of you don't know about. This happened in 1945. The war had ended. There was a Sgt. Matsuda who had received the Distinguished Service Cross serving in Germany. He died. His family was in Orange County and the award was to be given to the Sergeant there in Orange County. There was a movement to repel this. General Stillwell came from Washington to present this medal. Hollywood celebrities were asked to come also and Ronald Reagan was there. He said he was proud of Sgt. Matsuda, and this is what he said: "America stands unique in the world. The only country not founded on race but on a way, an ideal. Not in spite of, but because of our polyglot background, we have had all the strength in the world. That is the American way." Later, as President of the United States, he signed Redress HR 442 that acknowledged the Americans of Japanese ancestry. He was a great man and we will miss him dearly. Our thoughts and prayers are with Mrs. Reagan and the entire Reagan family.

#### by Majority Floor Leader Dario Frommer

Like my friend and colleague Mr. Strickland, I was also a kid during the Cold War and came of age in that 1980 period and was very, very much influenced by President Reagan, not to the point like my friend Tony was, but Reagan was really a uniquely American story. He was a guy who came from very humble beginnings who worked his way up. He was a radio announcer; he was a lifeguard; he became an actor and did very well in Hollywood; went on to become the head of the Screen Actor's Guild, and then later launched a career in politics. It really was an extraordinary ride for this young man from Dixon, Illinois. But I think what's really amazing about Reagan as a leader, whether you agree with him or not, was his optimism and his humor, but also Reagan's pragmatism. He was a principled guy and he was a conservative but Reagan never missed an opportunity to do the right thing. When confronted in California with an opportunity to save Lake Tahoe in the 1960's where there were concerns about the lake being despoiled, he joined with the Governor of Nevada for the first time to form a conservancy that has helped to keep the waters of that lake very blue and very clean. He also fought damming of rivers and fought to protect parts of the high Sierra and to establish the State Water Resources Control Board and the Air Resources Those were the accomplishments of a conservative Republican Governor. President Reagan, when he was Governor of California, campaigned against the lawlessness on the campuses of the universities at the time. Many of you remember that period of tumult. But as Governor, he increased spending for higher education three times. He tripled it while he was Governor and did much to improve the

campuses and the availability of funds for students on those campuses. He came to government in 1966 as a tax-cutting conservative who vowed to cut the size of government, but when he was confronted with a huge budget gap and a choice between having dramatic cuts in services in education or closing it, he took a courageous stand. He increased taxes. And later, when he could, he reduced them. But Reagan was always a pragmatist who sought solutions and sought to do the right thing. I remember being a college student when President Reagan was President, and studying abroad when the President announced an unpopular plan to put more missiles in the European theatre and there were marches and protests and I know many of us here, and abroad, marched against those nuclear weapons. I marveled at how, just a few years later, President Reagan sat down with Mikhail Gorbachev and negotiated one of the most far-reaching accords on arms control and disarmament ever achieved. Again, Reagan the pragmatist seizing an opportunity, an historical opportunity and doing the right thing. He was an amazing man, even to the end of his life. In 1994, realizing that he was suffering from the devastating disease Alzheimers, made a courageous final farewell to the American people in a letter he wrote describing and disclosing his condition and talking about it. He and his wife Nancy were huge advocates to make this illness on the front border of America's consciousness to explain what it was, how it affects people, and why it was important to pay attention to it. Prophetically, he wrote a line in that letter that I think would be good to listen to today because I think it sort of captures the essence of Reagan. In that letter he wrote in his closing line, "When the Lord calls me home, whenever that may be, I will leave with the greatest love for this country of ours and eternal optimism for its future." That was Reagan. He loved this country and he was an optimist, and we are all better for him being with us.

I was a very young man in 1964 when I heard then actor, soon to be politician, Ronald Reagan make a speech in support of the Republican nominee for President and it was clear to me at that point in time that we had a man who was going to be involved and was going to have a future and in fact, was a great communicator. He inspired me at the time and I was proud to watch and follow his career as a young CHP officer working for Mr. Reagan, in some capacity I guess. It should be recalled that it was Willie Brown and Ronald Reagan that were responsible for this beautiful, refurbished Capitol that we all work in. He did some great things in California. But, I want to speak a little bit about the perspective of Ronald Reagan from those close to him. My experience was with the CHP officers who provided bodyguard services to the Governor at that time. I had the opportunity to get to know a lot of those guys. I wasn't on the detail myself, but they marveled at the man. Because as all of us in this room know, sometimes we get very busy in our jobs, and his certainly is as big as ours, and it's easy to forget to be friendly and open

and thankful to the people working for you and around you, but Ronald Reagan was different. Many times after the motorcade had made its way through the streets, and after it was behind the barriers and out-of-sight, the officers would get off their motorcycles and as he exited his car he would make it a point to go down the line and shake the hands of every officer on the squad. And, they will never forget that that was the kind of person that he was. As a result of that, several of the officers in 1981, five days before he was to be inaugurated, decided to make a presentation to him of a commemorative pistol honoring the 50th Anniversary of the Highway Patrol at that time, and I was asked to go along and make that presentation. So, standing on the steps of his Bel Air home where he died just a few days ago, I had the privilege of meeting the President, having my picture taken with him, and making the presentation to that small group. I will never forget the many, many wonderful things he's done for this country, nor will I forget that very meaningful day in my life. I honor his memory; may he rest in peace; and, all our best wishes to his family.

I rise today with great sadness that we've lost a President, a Governor, a man of integrity, a wonderful husband and father. I was fortunate just this last week to be at a meeting on Wednesday where Michael Reagan was the speaker. I got to sit with him and talk about his dad, and he asked me, "What should I say today to these business leaders who are gathered?" I said "Talk about your dad and your relationship with him through the years." Although at times it had been strained, they had a great relationship prior to his disease being diagnosed, and he did, he shared for nearly an hour story after story about his dad and even about his dad when he lost. In 1976 he lost the Republican nomination for the presidency and Michael was right by his side and he said "Dad, what would you have done if you were President?" And even back then he said "I want to end the Cold War." And he really knew that the time would be right at some point, which happened four years later, that he would serve our great country as the President and eventually that would happen. One time, just a couple of years ago, standing in line for over two hours I think, at the Reagan Library waiting for her to sign a very unusual book. And, I got that book actually for my daughter-in-law and one for myself and talked to Nancy about that. And he was somebody, every day, who loved his wife. No matter what he did, he loved his wife. In 1965, I was the President of the University of San Diego Alumni Association, living in San Diego. One day, I received a call from the University office and they said, "Can you come out to the University and introduce a candidate for Governor?" So, I got out to the University of San Diego and Ronald Reagan was that candidate for Governor. By the way, as Governor Reagan soon to be, was making that presentation, there was another young gentleman by the name of Pete Wilson who was papering the parking lot with flyers saying "Vote for Pete Wilson for Assembly", so things are kind of close together. But, at any rate, I had the opportunity to introduce then citizen Reagan who would soon be the Governor and then ultimately the President. I remember I said, after a rather long presentation, that he would speak for 20 minutes and then take questions.
