These are the words I wished I could have shared with my childhood friend, Guy Ono, who took his own life in San Francisco in August of 2003. I miss him still. He made me laugh; he made me think; he kept me real.

Reflecting on the grief I've been revisiting this past week, this well-known quote by Maya Angelou grew even deeper in meaning. She said, "I've learned that people will forget what you said, people will forget what you did, but people will never forget how you made them feel."
