Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the effectiveness of the Fiscal Crisis and Management Assistance Team (FCMAT).

This report concludes that FCMAT's recommendations, if implemented, should help financially troubled school districts improve their financial conditions. Although all of the school districts we reviewed appeared to have implemented or partially implemented some of the recommendations we selected to review, many of them continue to experience financial problems. Full recovery can take several years, depending on the nature and severity of a district's problems. Since its formation, FCMAT's scope of responsibilities has significantly expanded, primarily as a result of legislation, to include comprehensive reviews and periodic progress reports of specific school districts that received state emergency loans, and projects such as the California School Information Services system, which is an electronic statewide system that facilitates the exchange of student information. FCMAT's studies cost an average of \$3.1 million annually for fiscal years 2000-01 through 2002-03, including \$2.1 million per year for management assistance studies and \$1 million per year for comprehensive reviews as mandated by legislation. Its billing rate of \$400 per person per day spent working on site at school districts and county education offices is on the low end of what FCMAT pays its consultants, which is consistent with FCMAT's understanding that the Legislature intended it to assist financially troubled school districts to avert a financial crisis, such as bankruptcy. Finally, FCMAT's administrative costs appear reasonable and although FCMAT is not subject to competitive bidding rules, it uses a fair process for selecting consultants for its large comprehensive reviews of school districts.

Mr. Speaker, Members of the Assembly:

Last week America lost a musical giant, in the person of Ray Charles.

His colleagues in the music industry called him a musical genius. He combined Country Western, Gospel, Soul, Jazz and Rhythm and Blues and brought joy to Americans in all walks of life. He loved a good laugh! Here is a picture of President Reagan and Mrs. Reagan with whom he is having a good laugh.

Some of his hits include: "Georgia on My Mind," 1960, No. 1; "Ruby," 1960, No. 28; "Hit the Road Jack," 1961, No. 1; "I Can't Stop Loving You," 1962, No. 1; "You Are My Sunshine," 1962, No. 7; "That Lucky Old Sun," 1963, No. 20.

He also won eight (8) Grammys:

1960: Best Vocal Performance Single Record or Track, Male, "Georgia on My Mind"

Best Performance by a Pop Single Artist, "Georgia on My Mind"

Best Rhythm and Blues Performance, "Let the Good Times Roll"

Best Vocal Performance Album, Male, "The Genius of Ray Charles"

1961: Best Rhythm and Blues Recording, "Hit the Road Jack"

1962: Best Rhythm and Blues Recording, "I Can't Stop Loving You"

My favorite song which sends chills through me is: *America the Beautiful*.

America the Beautiful

O beautiful for spacious skies,

For amber waves of grain,

For purple mountain majesties

Above the fruited plain!

America! America!

God shed His grace on thee

And crown thy good with brotherhood

From sea to shining sea!

Mr. Speaker, permit me to read a few paragraphs, written by the *Los Angeles Times* music critic Robert Hilburn, and I quote:

“What may ultimately prove his most enduring piece of music was his 1972 reworking of “America the Beautiful.”

Recorded amid the racial tensions that still plagued the country, Charles, working with arranger and longtime friend Quincy Jones, divided the song into sections and kept only what he felt were the most pertinent lyrics.

He introduces one section by saying, “You know, when I was in school, we used to sing it something like this, listen here.” He then sings with the sweetness and innocence of a child: “Oh beautiful, for spacious skies/ For amber waves of grain . . . ” Suddenly, though, he begins applying his soulful dynamics. “But now wait a minute, I’m talking about America, sweet America, you know, God done shed His grace on thee.”

He injects a transfixing passion and optimism into the song, evoking all that is good about the country. But he’s also determined to make it more than a patriotic, feel-good experience, so there’s a pain and longing in his voice that carries a reminder of the distance between the country’s ideals and its practices.

Few artists have been able to touch us as deeply and consistently as Charles. But then, few artists are such direct links to our heart and soul.

Mr. Speaker, today when we adjourn, let’s do so in his memory.
