PRAYER

Upon invitation of Speaker pro Tempore Mullin, the following prayer was offered by Assembly Chaplain Rev. Bob Oshita:

Please join me in a moment of reflection.

I'd like to share one of my favorite stories about the well-known monk, Shinran, who lived 800 years ago in Japan. Shinran embodied the virtues of undeniable honesty and humility. Although considered accomplished by his teacher, Master Honen, deep within, Shinran was confused. In personal despair, he went to Honen and asked his teacher, "What shall I do with my life?" Honen's response was one that has quietly guided my life for almost 50 years. Honen replied to Shinran, "The most important thing to do is to live your life with kindness and gratitude." He went on to add, "If you can't live such a life as a monk, do it as a layman. If you can't live it as a layman, do it as a monk. If you can't live a life of gratitude alone, then do it with people. If you can't do it with people, live such a life alone. If you can't stay in one place living with kindness, then move around and do it. If you can't do it moving around, then stay in one place. But most important and most essential, is to simply live your life with true kindness and gratitude."

Shinran knew that deep within, his nature was in conflict with the path of tradition. However, his teacher, Honen, had the confidence to entrust him to respond honestly to his own true nature. Honen was trusting Shinran to find his own path, explaining that there is no single path to fulfillment. Shinran's life of kindness and gratitude naturally grew from having his life genuinely fulfilled.

When there have been moments of confusion in my life, this story has come to mind and I have been made to remember again that we must find the courage to be true to ourselves; and from our genuine fulfillment, a life of kindness and gratitude will flow.
