**SWEARING-IN CEREMONY FOR TINA S. MCKINNON
ASSEMBLY MEMBER-ELECT FOR THE 62ND ASSEMBLY DISTRICT**

Assembly Member-elect Tina S. McKinnor was sworn in during a special ceremony today, at 11 a.m., in the Assembly Chamber prior to the convening of Floor Session.

Speaker Anthony Rendon, 63rd Assembly District, presiding.

PRAYER

Upon invitation of Speaker Rendon, the following prayer was offered by Reverend Eddie Anderson, Senior Pastor at McCarty Memorial Christian Church in Los Angeles:

God of our weary years, God of our silent tears. The Creator of the universe and that which is yet to come. We thank You as we gather in this Month of Pride where we celebrate the dignity of love, that You are not only a God of love, but a God that sees and hears us as well.

So God, on this sacred day where we commemorate the Freedom of Black people who helped build this very land—which was originally steward by the Nisenan and toiled by the hands of folk who only dreamed of freedom, though delayed but not denied—we thank You that on this the most sacred of days, that You have called for such a time as this, the manifestation of our ancestors' prayers, Tina McKinnor to serve in this august Body.

We pray, O God, that in this Chamber that You would open unto Tina and every Member she is to serve with: light for our darkness that has swept the land, and has turned promises into platitudes, and has caused this Golden state to not follow the Golden rule, but bow to the policy violence which turns neighborhoods into hoods. Help Tina to always be guided by Your light to give truth, crushed to earth, the sun to rise again.

O Adonai, open up unto Tina and this Chamber: courage when there is fear. For the time is still always ripe to do right not for the select few, but for the most equitable outcome in this state, where housing still seems unaffordable for some, and the California dream has turned into a nightmare of struggle for so many. Give her courage, God, to be a voice that speaks up amongst the fear.

God, open unto Tina and all in this Chamber: hope for grave despair, when the negotiable seems unattainable, and the problems we face seem too large. Remind her that You are still there and power of the people is near. Open unto Tina: peace in the midst of turmoil, economic, racial, and environmental.

Open unto this Chamber: joy for sorrow. May she and everyone in here serve the people by loving the people, all the people, in this post-pandemic reality, especially the poor, the labor union member, the single mother and the foster child, the immigrant and the migrant, and especially Your children who know the sorrow of oppression and the burden of militarism and racism.

Open unto Tina: strength for weakness. Open unto this Chamber: wisdom for confusion. Open unto Tina and all of us: forgiveness for our sins. Open unto this Chamber: love for the many hate she will endure for being a legislator that will write with a pen of justice, and author with a heart of faith and love in the greater good.

Lord, Lord, bless her coming in and her going out, her family and friends. Facing the rising sun of a new day begun, let her march on until victory is won.—AMEN.
